



**Order under Section 69
Residential Tenancies Act, 2006**

Between: Cornelia Investments Limited c/o Gossner & Hornar Management Ltd. Landlord

And

Serhat Yilmaz Tenant

The application is amended to remove Onder Yasor as a party to the matter.

Cornelia Investments Limited c/o Gossner & Hornar Management Ltd. (the 'Landlord') applied for an order to terminate the tenancy and evict Serhat Yilmaz (the 'Tenant') because the Tenant did not pay the rent that the Tenant owes.

This application was heard by videoconference on December 22, 2025.

The Landlord's Representative, Mark Ciobotaru, and the Tenant resolved their matter directly and without mediation services and agreed to an Order on Consent in full and final satisfaction of the application, and in so doing, understand that their legal rights to a hearing on the merits of the matter have been waived.

I was satisfied that the terms of this agreement are consistent with the *Residential Tenancies Act, 2006*.

I was satisfied that the parties have provided their informed, independent, and voluntary consent.

The parties before the LTB consented to the following order:

It is agreed that:

1. The Tenant claimed that Onder Yasor moved out of the rental unit on or about July 1, 2025.

It is ordered on consent that:

1. The Tenant shall pay to the Landlord \$12,892.13 for arrears of rent up to December 31, 2025 and costs.
2. The Tenant shall pay to the Landlord the amount set out in paragraph 1 in accordance with the following schedule:

- i) \$5,500.00 by December 23, 2025;
 - ii) \$1,000.00 by January 20, 2026;
 - iii) \$1,000.00 by February 20, 2026;
 - iv) \$1,000.00 by March 20, 2026;
 - v) \$1,000.00 by April 20, 2026;
 - vi) \$1,000.00 by May 20, 2026;
 - vii) \$1,000.00 by June 20, 2026; and
 - viii) \$1,392.13 by July 20, 2026.
3. The Tenant shall also pay to the Landlord new rent on time and in full as it comes due and owing, by the first day of each month, for the period January 1, 2026 to July 1, 2026, or until the arrears are paid in full, whichever date is earliest.
4. If the Tenant fails to make any one of the payments in accordance with this order, the outstanding balance of any arrears of rent and costs to be paid by the Tenant to the Landlord pursuant to paragraph 1 of this order shall become immediately due and owing and the Landlord may, without notice to the Tenant, apply to the LTB within 30 days of the Tenant's breach pursuant to section 78 of the Act for an order terminating the tenancy and evicting the Tenant and requiring that the Tenant pay any new arrears, NSF fees and related charges that became owing after December 31, 2025.
