



Order under Section 69 Residential Tenancies Act, 2006

Metcap Living Management Inc. (the 'Landlord') applied for an order to terminate the tenancy and evict Shane Peter Malcolm and Andralete Fray (the 'Tenants') because the Tenants did not pay the rent that the Tenants owe.

This application was mediated by videoconference on December 17, 2025.

The Landlord Representative Moeez Nabi and the Tenants Shane Peter Malcolm and Andralete Fray attended the hearing.

The parties mutually agreed to resolve all matters at issue in the application and requested an order on consent and I am satisfied that the parties understand the consequences of their consent.

Agreed Facts:

1. As of the hearing date, the Tenants were still in possession of the rental unit.
2. The lawful rent is \$1,456.88. It is due on the 1st day of each month.
3. The rent arrears owing to December 31, 2025 are \$3,226.06.
4. The Landlord incurred costs of \$186.00 for filing the application and is entitled to reimbursement of those costs.
5. Accordingly, the total amount the Tenants owe the Landlord is \$3,412.06.

It is ordered on consent that:

1. The Tenants shall pay to the Landlord \$3,412.06 for arrears of rent up to December 31, 2025 and costs.
2. The Tenants shall pay to the Landlord the amount set out in paragraph 1 in accordance with the following schedule:
 - a) **\$568.67** on or before the **20th day** of each month starting **January 20, 2026**, through to and including **May 20, 2026**, and;
 - b) A final payment of **\$568.71** on or before **June 20, 2026**.
3. The Tenants shall also pay to the Landlord new rent on time and in full as it comes due and owing for the period **January 1, 2026** to **June 1, 2026**, or until the arrears are paid in full, whichever date is earliest.
4. If the Tenants fail to make any one of the payments in accordance with this order, the outstanding balance of any arrears of rent and costs to be paid by the Tenants to the Landlord pursuant to paragraph 1 of this order shall become immediately due and owing and the Landlord may, without notice to the Tenants, apply to the LTB within 30 days of the Tenants' breach pursuant to section 78 of the Act for an order terminating the tenancy and evicting the Tenants and requiring that the Tenants pay any new arrears, NSF fees and related charges that became owing after **December 31, 2025**.
