



**Order under Section 69
Residential Tenancies Act, 2006**

In the matter of: 207, 21 ECCLESTON DR

Between: Pinedale Properties Ltd. Landlord

And

Elizabeth Charles Tenant

Pinedale Properties Ltd. (the 'Landlord') applied for an order to terminate the tenancy and evict Elizabeth Charles (the 'Tenant') because the Tenant did not pay the rent that the Tenant owes.

The application was scheduled to be heard by video conference on January 13, 2026. Before the start of the hearing, the Landlord's Representative, Frannie Simms, the Landlord's agent, Mario Gambelic and the Tenant advised that the parties had reached an agreement. The Tenant met with Duty Counsel prior to the hearing.

The parties requested that Dispute Resolution Officer (DRO) Sarah Visnovec issue an order on consent to resolve all matters raised in the application.

Upon reviewing the terms of the consent with the parties, I was satisfied that the parties understood the terms and consequences of their consent.

On consent, it is ordered that:

1. The Tenant shall pay to the Landlord **\$2,414.00**, which represents the arrears of rent (\$2,228.00) and costs (\$186.00) outstanding for the period ending January 31, 2026.
2. The Tenant shall pay to the Landlord the amount set out in paragraph 1 in accordance with the following schedule:

Date Payment Due	Amount of Payment
February 1, 2026	\$400.00
March 1, 2026	\$400.00
April 1, 2026	\$400.00
May 1, 2026	\$400.00
June 1, 2026	\$400.00
July 1, 2026	\$414.00

3. The Tenant shall also pay the Landlord the rent in full, on or before the first day of each corresponding month for the months of February 2026 to July 2026, or until there are no arrears owing, whichever comes first.
4. If the Tenant fails to make any one of the payments in accordance with this order, the outstanding balance of any arrears of rent and costs to be paid by the Tenant to the Landlord pursuant to paragraph 1 of this order shall become immediately due and owing and the Landlord may, without notice to the Tenant, apply to the LTB within 30 days of the Tenant's breach pursuant to section 78 of the Act for an order terminating the tenancy and evicting the Tenant and requiring that the Tenant pay any new arrears, NSF fees and related charges that became owing after January 31, 2026.
