



**Order under Section 69
Residential Tenancies Act, 2006**

And

Subramaniam Sriskandarajah Tenants
Inthumathi Seiskandarajah

20 Stonehill Inc. (the 'Landlord') applied for an order to terminate the tenancy and evict Subramaniam Sriskandarajah and Inthumathi Seiskandarajah (the 'Tenants') because the Tenants did not pay the rent that the Tenants owe.

This application was heard by videoconference on January 13, 2026.

Only the Landlord's Representative, Sharon Harris, attended the hearing.

As of 9:34 a.m., the Tenants were not present or represented at the hearing although properly served with notice of this hearing by the LTB. There was no record of a request to adjourn the hearing. As a result, the hearing proceeded with only the Landlord's evidence.

Determinations:

1. The Landlord served the Tenants with a valid Notice to End Tenancy Early for Non-payment of Rent (N4 Notice). The Tenants did not void the notice by paying the amount of rent arrears owing by the termination date in the N4 Notice or before the date the application was filed.
2. The Tenants were in possession of the rental unit on the date the application was filed.
3. The Tenants vacated the rental unit on November 30, 2025. Rent arrears are calculated up to the date the Tenants vacated the unit
4. The lawful rent is \$1,708.60. It was due on the 1st day of each month.
5. The Tenants have paid \$1,708.60 to the Landlord since the application was filed.
6. The rent arrears owing to November 30, 2025, are \$1,708.60.

7. The Landlord incurred costs of \$186.00 for filing the application and is entitled to reimbursement of those costs.
8. The Landlord collected a rent deposit of \$1,708.60 from the Tenants and this deposit is still being held by the Landlord. The rent deposit is applied to the arrears of rent because the tenancy terminated.
9. Interest on the rent deposit, in the amount of \$477.61 is owing to the Tenants for the period from June 1, 2010, to November 30, 2025.

It is ordered that:

1. The tenancy between the Landlord and the Tenants is terminated as of November 30, 2025, the date the Tenants moved out of the rental unit.
2. The Landlord shall pay to the Tenants \$291.61. The Tenants owe the Landlord rent arrears owing up to the date the Tenants moved out of the rental unit and the cost of filing the application. The amount of rent deposit and interest the Landlord owes on the rent deposit exceeds the amount owing by the Tenants. See Schedule 1 for the calculation of the amount owing.
3. If the Landlord does not pay the Tenants the full amount owing on or before February 6, 2026, the Landlord will start to owe interest. This will be simple interest calculated from February 7, 2026, at 4.00% annually on the balance outstanding.
