



Order under Section 69 Residential Tenancies Act, 2006

Bidemi Omoyajowo Tenant

30 Gilder Drive Apts (the 'Landlord') applied for an order to terminate the tenancy and evict Bidemi Omoyajowo (the 'Tenant') because the Tenant did not pay the rent that the Tenant owes.

The application was scheduled to be heard by video conference on January 15, 2026.

Before the start of the hearing the Landlord's legal representative Carrie Aylwin and the Tenant Bidemi Omoyajowo engaged in private settlement discussions and advised that the parties had reached an agreement.

The parties requested that Dispute Resolution Officer (DRO) Diego Fernandez-Stoll provide assistance in finalizing the terms and issue an order on consent to resolve all matters raised in the application.

Upon reviewing the terms of the consent with the parties, I was satisfied that the parties understood the terms and consequences of their consent.

The parties agreed:

1. The total arrears of rent owing up to January 31, 2026, including the application filing fee are \$4,889.00.

It is ordered on consent that:

1. The Tenant shall pay to the Landlord **\$4,889.00** for arrears of rent up to January 31, 2026, and costs.
2. The Tenant shall pay to the Landlord the amount set out in paragraph 1 in accordance with the following schedule:
 - a) \$349.21 payable on or before February 23, 2026
 - b) \$349.21 payable on or before March 23, 2026
 - c) \$349.21 payable on or before April 23, 2026
 - d) \$349.21 payable on or before May 23, 2026

- e) \$349.21 payable on or before June 23, 2026
 - f) \$349.21 payable on or before July 23, 2026
 - g) \$349.21 payable on or before August 23, 2026
 - h) \$349.21 payable on or before September 23, 2026
 - i) \$349.21 payable on or before October 23, 2026
 - j) \$349.21 payable on or before November 23, 2026
 - k) \$349.21 payable on or before December 23, 2026
 - l) \$349.21 payable on or before January 23, 2027
 - m) \$349.21 payable on or before February 23, 2027
 - n) \$349.27 payable on or before March 23, 2027
3. The Tenant shall also pay to the Landlord new rent on time and in full as it comes due and owing for the period **February 1, 2026**, through to and including **March 1, 2027**, or until the arrears are paid in full, whichever date is earliest.
4. If the Tenant fails to make any one of the payments in accordance with this order, the outstanding balance of any arrears of rent and costs to be paid by the Tenant to the Landlord pursuant to paragraph 1 of this order shall become immediately due and owing and the Landlord may, without notice to the Tenant, apply to the LTB within 30 days of the Tenant's breach pursuant to section 78 of the Act for an order terminating the tenancy and evicting the Tenant and requiring that the Tenant pay any new arrears, NSF fees and related charges that became owing after **January 31, 2026**.
