



**Order under Section 69
Residential Tenancies Act, 2006**

File Number: LTB-L-092242-25

In the matter of: 101, 25 VILLA RD
ETOBICOKE ON M8W1M4

Between: Greenwin Corp Landlord

And

Nia-Sadique Guillemette Tenant

Greenwin Corp (the 'Landlord') applied for an order to terminate the tenancy and evict Nia-Sadique Guillemette (the 'Tenant') because the Tenant did not pay the rent that the Tenant owes.

This application was heard by videoconference on January 22, 2026.

The Landlord's legal representative, Matt Anderson, and the Tenant attended the hearing.

Determinations:

1. The Landlord served the Tenant with a valid Notice to End Tenancy Early for Non-payment of Rent (N4 Notice). The Tenant did not void the notice by paying the amount of rent arrears owing by the termination date in the N4 Notice or before the date the application was filed.
2. The Tenant was in possession of the rental unit on the date the application was filed.
3. The Tenant vacated the rental unit on January 8, 2026. Rent arrears are calculated up to the date the Tenant vacated the unit
4. The lawful rent is \$3,014.22. It was due on the 1st day of each month.
5. The Tenant has paid \$1,120.00 to the Landlord since the application was filed.
6. The rent arrears owing to January 8, 2026 are \$6,768.46.
7. The Landlord incurred costs of \$186.00 for filing the application and is entitled to reimbursement of those costs.
8. The Landlord collected a rent deposit of \$2,944.92 from the Tenant and this deposit is still being held by the Landlord. The rent deposit is applied to the arrears of rent because the tenancy terminated.

9. Interest on the rent deposit, in the amount of \$74.98 is owing to the Tenant for the period from January 1, 2025, to January 8, 2026.
10. On consent, the parties agreed that the Tenant shall be given until March 31, 2026, to pay the arrears and costs owing before interest will start.

It is ordered that:

1. The tenancy between the Landlord and the Tenant is terminated as of January 8, 2026, the date the Tenant moved out of the rental unit.
2. The Tenant shall pay to the Landlord \$3,934.56. This amount includes rent arrears owing up to the date the Tenant moved out of the rental unit and the cost of filing the application. The rent deposit and interest the Landlord owes on the rent deposit is deducted from the amount owing by the Tenant. See Schedule 1 for the calculation of the amount owing.
3. If the Tenant does not pay the Landlord the full amount owing on or before March 31, 2026, the Tenant will start to owe interest. This will be simple interest calculated from April 1, 2026 at 4.00% annually on the balance outstanding.
