



**Order under Section 69
Residential Tenancies Act, 2006**

Between: TORONTO COMMUNITY HOUSING CORPORATION Landlord

And

TIFFANIE JOHNSON Tenant

TORONTO COMMUNITY HOUSING CORPORATION (the 'Landlord') applied for an order to terminate the tenancy and evict TIFFANIE JOHNSON (the 'Tenant') because the Tenant did not pay the rent that the Tenant owes.

The Landlord's agent Elida Myrtaj and the Tenant advised by way of the Online Dispute Resolution Tool on the Tribunals Ontario Portal that they wished to engage in mediation in advance of their hearing date.

The parties participated in a mediation videoconference on January 26, 2026. As a result of the resolution discussion, the parties mutually agreed to resolve all matters at issue in the application and requested an order on consent. I was satisfied that the parties understood the terms and consequences of their consent.

It is ordered on consent that:

1. The Tenant shall pay to the Landlord \$5,966.74 which represents arrears of rent (\$5,780.74) plus the application filing fee (\$186.00) for the period ending January 31, 2026.
2. The Tenant shall pay to the Landlord the amount set out in paragraph 1 in accordance with the following schedule:
 - Payments of \$75.00 on or before the 20th day of each month starting on February 20, 2026, and continuing each month until August 20, 2032; and
 - a final payment of \$41.74 on or before September 20, 2032.
3. The Tenant shall also pay to the Landlord new rent on time and in full as it comes due and owing for the period February 1, 2026 to September 1, 2032, or until the arrears are paid in full, whichever date is earliest.

4. If the Tenant fails to make any one of the payments in accordance with this order, the outstanding balance of any arrears of rent and costs to be paid by the Tenant to the Landlord pursuant to paragraph 1 of this order shall become immediately due and owing and the Landlord may, without notice to the Tenant, apply to the LTB within 30 days of the Tenant's breach pursuant to section 78 of the Act for an order terminating the tenancy and evicting the Tenant and requiring that the Tenant pay any new arrears, NSF fees and related charges that became owing after January 31, 2026.
5. The hearing scheduled for March 5, 2026 is cancelled.
