



**Order under Section 69
Residential Tenancies Act, 2006**

Between: WESTDALE PROPERTIES Landlord

and

ILGIT AKAR Tenant

WESTDALE PROPERTIES (the 'Landlord') applied for an order to terminate the tenancy and evict ILGIT AKAR (the 'Tenant') because the Tenant did not pay the rent that the Tenant owes.

This application was scheduled for a videoconference hearing on January 28, 2026.

The Landlord's Agent Elizabeth Fera and the Tenant engaged in private settlement discussions on the day of the hearing. Parties reached an agreement and requested an order on consent. The Tenant received legal advice about this application.

I am satisfied that the parties understand the consequences of their consent, including waiving their right to a hearing on this application.

Agreed Facts:

- 1) The current rent increased to \$1,525.73 on December 1, 2025. It is due on the 1st day of each month.
- 2) Based on the Monthly rent, the daily rent/compensation is \$50.16. This amount is calculated as follows: \$1,525.73 x 12 months, divided by 365 days.
- 3) The rent arrears owing to January 31, 2026 are \$6,028.50.
- 4) The Landlord incurred costs of \$186.00 for filing the application and is entitled to reimbursement of those costs.

- 5) The Landlord collected a rent deposit of \$1,488.52 from the Tenant and this deposit is still being held by the Landlord. The rent deposit can only be applied to the last rental period of the tenancy if the tenancy is terminated.
- 6) Interest on the rent deposit, in the amount of \$42.27 is owing to the Tenant for the period from December 1, 2024 to January 28, 2026.

It is ordered on consent of the parties that:

1. The tenancy between the Landlord and the Tenant is terminated unless the Tenant voids this order.
2. **The Tenant may void this order and continue the tenancy by paying to the Landlord or to the LTB in trust:**
 - \$6,214.50 if the payment is made on or before January 31, 2026. See Schedule 1 for the calculation of the amount owing.
 - \$7,740.23 if the payment is made on or before February 28, 2026. See Schedule 1 for the calculation of the amount owing.
3. The Tenant may also make a motion at the LTB to void this order under section 74(11) of the Act, if the Tenant has paid the full amount owing as ordered plus any additional rent that became due after February 28, 2026 but before the Court Enforcement Office (Sheriff) enforces the eviction. The Tenant may only make this motion once during the tenancy.
4. **If the Tenant does not pay the amount required to void this order the Tenant must move out of the rental unit on or before February 28, 2026.**
5. If the Tenant does not void the order, the Tenant shall pay to the Landlord \$4,562.46. This amount includes rent arrears owing up to the date of the hearing and the cost of filing the application. The rent deposit and interest the Landlord owes on the rent deposit are deducted from the amount owing by the Tenant. See Schedule 1 for the calculation of the amount owing.
6. The Tenant shall also pay the Landlord compensation of \$50.16 per day for the use of the unit starting January 29, 2026 until the date the Tenant moves out of the unit.
7. If the Tenant does not pay the Landlord the full amount owing on or before February 28, 2026, the Tenant will start to owe interest. This will be simple interest calculated from March 1, 2026 at 4.00% annually on the balance outstanding.
8. If the unit is not vacated on or before February 28, 2026, then starting March 1, 2026, the Landlord may file this order with the Court Enforcement Office (Sheriff) so that the eviction may be enforced.
9. Upon receipt of this order, the Court Enforcement Office (Sheriff) is directed to give vacant possession of the unit to the Landlord on or after March 1, 2026.

10. This order is in full and final settlement of this application.

Total the Tenant must pay to continue the tenancy	\$7,740.23

C. Amount the Tenant must pay if the tenancy is terminated

Application Filing Fee	\$186.00
Less the amount of the last month's rent deposit	- \$1,488.52
Less the amount of the interest on the last month's rent deposit	- \$42.27
Total amount owing to the Landlord	\$4,562.46
Plus daily compensation owing for each day of occupation starting January 29, 2026	\$50.16 (per day)
**Ongoing daily compensation continues to accumulate until the total amount owing (excluding costs) is \$50,000.00.
