



**Order under Section 69
Residential Tenancies Act, 2006**

Siteline (3111 Eglinton) Inc. (the 'Landlord') applied to the Landlord and Tenant Board (LTB) for an order to terminate the tenancy and evict Rochelle Glen (the 'Tenant') because the Tenant did not pay the rent that the Tenant owes.

The application was scheduled to be heard on January 19, 2026, by video conference, at which time the parties decided to participate in Board facilitated mediation with the assistance of Dispute Resolution Officer/Hearings Officer, Dillanique Knight.

The Landlord's Representative, Sara Ginman, and the Tenant were present. The Tenant did speak with Tenant Duty Counsel prior to mediation.

As a result of the mediation the parties mutually agreed to resolve all matters at issue in the application and requested an order on consent and I am satisfied that the parties understand the consequences of their consent.

It is ordered on consent that:

1. The Tenant shall pay to the Landlord \$1,198.80. This amount represents \$1,012.80 for arrears of rent up to January 31, 2026, and \$186.00 for the application filing fee.
2. Tenant shall pay to the Landlords the amount set out in paragraph 1 in accordance with the following schedule.

Date of Payment	Payment Amount
February 20, 2026	\$200.00
March 20, 2026	\$200.00
April 20, 2026	\$200.00
May 20, 2026	\$200.00

June 20, 2026	\$200.00
July 20, 2026	\$198.80

3. The Tenant shall also pay to the Landlord new rent on time and in full as it comes due and owing for the period February 1, 2026, to July 1, 2026, or until the arrears are paid in full, whichever date is earliest.
4. If the Tenant fails to make any one of the payments in accordance with this order, the outstanding balance of any arrears of rent and costs to be paid by the Tenant to the Landlord pursuant to paragraph 1 of this order shall become immediately due and owing and the Landlord may, without notice to the Tenant, apply to the LTB within 30 days of the Tenant's breach pursuant to section 78 of the Act for an order terminating the tenancy and evicting the Tenant and requiring that the Tenant pay any new arrears, NSF fees and related charges that became owing after January 31, 2026.
