



**Order under Section 69
Residential Tenancies Act, 2006**

CAPREIT 2 LIMITED PARTNERSHIP (the 'Landlord') applied for an order to terminate the tenancy and evict SONIA ANNMARIE DALEY and IDIAT ADEKUNLE (the 'Tenants') because the Tenants did not pay the rent that the Tenants owe.

This application was scheduled to be heard by videoconference on January 28, 2026. On that date the parties agreed to participate in Board facilitated mediation with the assistance of Dispute Resolution Officer (DRO) Rachael Kukoyi.

The Landlord's Representative, Jason Paine, and the Tenant, Sonia Annmarie Daley (representing both Tenants), participated in the mediation.

As a result of the mediation, the parties requested an order on consent and I am satisfied that the parties understand the terms and consequences of their consent, including waiving their right to a hearing on this application.

The Parties Agreed That:

1. As of the hearing date, the Tenants were still in possession of the rental unit.
2. The lawful rent is due on the 1st day of each month.
3. The Tenants have paid \$2,700.00 to the Landlord since the application was filed.
4. The rent arrears owing to January 31, 2026, are \$1,830.64.
5. The Landlord incurred costs of \$186.00 for filing the application and is entitled to reimbursement of those costs.

6. Accordingly, the total amount the Tenants owe the Landlord is \$2,016.64.

It is ordered on consent that:

1. The Tenants shall pay to the Landlord \$2,016.64. This amount includes rent arrears owing up to January 31, 2026, and the cost of the application.
2. The Tenants shall pay to the Landlord the amount set out in paragraph 1 through a payment plan whereby the Tenants will pay the Landlord:
 - \$400.00 a month on or before the 20th day of each month, beginning February 20, 2026, up to and including May 20, 2026; and
 - \$416.64 on or before June 20, 2026.
3. The Tenants shall pay to the Landlord new rent as follows or until the arrears have been paid in full, whichever comes first:
 - a) February 2026 rent by February 5, 2026;
 - b) March 2026 rent by March 5, 2026;
 - c) April 2026 rent by April 2, 2026;
 - d) May 2026 rent by May 1, 2026;
 - e) June 2026 rent by June 1, 2026.
4. If the Tenants fail to make any of the payments in accordance with this order, the outstanding balance of any arrears of rent and costs to be paid by the Tenants to the Landlord pursuant to this order shall become immediately due and owing and the Landlord may, without notice to the Tenants, apply to the LTB within 30 days of the Tenants' breach pursuant to section 78 of the Act for an order terminating the tenancy and evicting the Tenants and requiring that the Tenants pay any new arrears, NSF fees and related charges that became owing after January 31, 2026.
