



Order under Section 69 Residential Tenancies Act, 2006

2755 JANE STREET INC. (the 'Landlord') applied for an order to terminate the tenancy and evict YVETTE SHAW (the 'Tenant') because the Tenant did not pay the rent that the Tenant owes.

This application was scheduled to be heard by videoconference on January 26, 2026. The Landlord's legal representative, Sabrina Marchionne, the Tenant's legal representative, Ricardo Colonnese and the Tenant attended the hearing.

Before the start of the hearing, the parties advised that they had reached an agreement. As a result of the resolution discussion, the parties mutually agreed to resolve all matters at issue in the application and requested an order on consent.

I was satisfied that the parties understood the terms and consequences of their consent.

Agreed Facts:

1. The lawful monthly rent is \$1,762.59. It is due on the 1st day of each month.
2. The arrears of rent owing to January 31, 2026, inclusive of the application filing fee of \$186.00 are \$10,631.89.

It is ordered on consent that:

1. The Tenant shall pay to the Landlord \$10,631.89, which represents the arrears of rent owing to January 31, 2026, and the application filing fee of \$186.00.
2. The Tenant shall pay to the Landlord the amount set out in paragraph 1 in accordance with the following schedule:
 - a. \$4,000.00 on or before January 28, 2026;
 - b. Payments of \$552.66 on or before the 15th day of each month starting February 15, 2026, and continuing each month until December 15, 2026; and
 - c. A final payment of \$552.63 on or before January 15, 2027.

3. The Tenant shall also pay to the Landlord new rent on time and in full as it comes due and owing on the 1st day of each month, for the period starting February 1, 2026, and continuing each month until January 1, 2027, or until the arrears are paid in full, whichever date is earliest.
4. If the Tenant fails to make any one of the payments in accordance with this order, the outstanding balance of any arrears of rent and costs owed to the Landlord by the Tenant pursuant to paragraph 1 of this order shall become immediately due and owing and the Landlord may, without notice to the Tenant, apply to the LTB within 30 days of the Tenant's breach pursuant to section 78 of the *Residential Tenancies Act, 2006* (the 'Act') for an order terminating the tenancy and evicting the Tenant and requiring that the Tenant pay any new arrears, NSF fees and related charges that became owing after January 31, 2026.
