**Order under Section 69
Residential Tenancies Act, 2006**

SKPM Rents 3 (the 'Landlord') applied for an order to terminate the tenancy and evict PANKIL PATEL and DEEP PATEL (the 'Tenant's') because the Tenants did not pay the rent that the Tenant owes.

This application was heard by videoconference on February 5, 2026.

The Landlords Legal Representative Sharon Harris and the Tenants attended the hearing.

The parties requested that Dispute Resolution Officer (DRO) Jennifer Buckminster provide assistance in finalizing the terms and issue an order on consent to resolve all matters raised in the application.

Upon reviewing the terms of the consent with the parties, I was satisfied that the parties understood the terms and consequences of their consent.

It is ordered on consent that:

1. The lawful rent is \$3,269.54. It is due on the day first day of each month.
2. Based on the Monthly rent, the daily rent/compensation is \$107.49. This amount is calculated as follows: $\$3,269.54 \times 12$, divided by 365 days.
3. The Tenants have paid \$7,600.00 to the Landlord since the application was filed.
4. The Landlord incurred costs of \$186.00 for filing the application and is entitled to reimbursement of those costs.

5. The Landlord collected a rent deposit of \$3,269.97 from the Tenants and this deposit is still being held by the Landlord. The rent deposit can only be applied to the last rental period of the tenancy if the tenancy is terminated.
6. The tenancy between the Landlord and the Tenants is terminated unless the Tenants void this order.
7. **The Tenants may void this order and continue the tenancy by paying to the Landlord or to the LTB in trust:**
 - a. \$5,833.16 if the payment is made on or before February 28, 2026. See Schedule 1 for the calculation of the amount owing.
8. The Tenants may also make a motion at the LTB to void this order under section 74(11) of the Act, if the Tenants have paid the full amount owing as ordered plus any additional rent that became due after February 28, 2026, but before the Court Enforcement Office (Sheriff) enforces the eviction. The Tenant may only make this motion once during the tenancy.
9. **If the Tenants do not pay the amount required to void this order the Tenants must move out of the rental unit on or before February 28, 2026.**
10. If the Tenants do not void the order, the Tenants shall pay to the Landlord \$261.06. This amount includes rent arrears owing up to the date of the hearing and the cost of filing the application. The rent deposit and interest the Landlord owes on the rent deposit are deducted from the amount owing by the Tenant. See Schedule 1 for the calculation of the amount owing.
11. The Tenants shall also pay the Landlord compensation of \$107.49 per day for the use of the unit starting February 10, 2026, until the date the Tenants moves out of the unit.
12. If the Tenants do not pay the Landlord the full amount owing on or before February 28, 2026, the Tenants will start to owe interest. This will be simple interest calculated from March 1, 2026, at 4.00% annually on the balance outstanding.
13. If the unit is not vacated on or before February 28, 2026, then starting March 1, 2026, the Landlord may file this order with the Court Enforcement Office (Sheriff) so that the eviction may be enforced.
14. Upon receipt of this order, the Court Enforcement Office (Sheriff) is directed to give vacant possession of the unit to the Landlord on or after March 1, 2026.
