



Order under Section 69 Residential Tenancies Act, 2006

1351895 Ontario Limited (the 'Landlord') filed an L1 application for an order to terminate the tenancy and evict Nramseen Slewa and Kathrin Kamal (the 'Tenants') based on a form N4 notice of termination because the Tenants did not pay the rent that the Tenants owe.

The parties requested an order on consent at the LTB online portal and as a result a teleconference call took place at the Landlord and Tenant Board on February 11, 2026 with the Hearing Officer Chris Jackson. The Landlord's Agent Patricia Marshall attended. The Tenant Nramseen Slewa attended and was self-represented. Kathrin Kamal the other Tenant in this matter was not in attendance, however Nramseen Slewa confirmed that he had authority to reach an agreement on behalf of Kathrin Kamal.

The parties mutually agreed to resolve all matters at issue in the application and requested an order on consent. I was satisfied that the parties understood the consequences of the joint submission.

The parties before the LTB consented to the following order.

On consent, it is ordered that:

1. The total sum of arrears owing up to and including February 28, 2026 as of today's date of February 11, 2026 is \$4,697.56 which includes the application filing fee of \$186.00.
2. The Tenants shall pay the total sum of arrears of \$4,697.56 as noted in paragraph 1 according to the date and amount of each payment as follows:
 - a) On or before March 1, 2026 and on or before the 1st (first) day of each consecutive month thereafter for the next 1 month (2 months total including the start date) up to and including April 1, 2026 or until the arrears are paid in full, whichever date is earliest, the Tenants shall pay lawful monthly rent on time and in full.
 - b) On or before February 13, 2026 the amount of \$850.00 towards the arrears.

- c) On or before February 20, 2026 the amount of \$850.00 towards the arrears.
 - d) On or before March 15, 2026 the amount of \$850.00 towards the arrears.
 - e) On or before March 22, 2026 the amount of \$850.00 towards the arrears.
 - f) On or before April 11, 2026 the amount of \$850.00 towards the arrears.
 - g) On or before April 18, 2026 the remaining outstanding balance of arrears in the amount of \$447.56.
3. If the Tenants fail to comply with any one of the payments noted in paragraph 2 of this order related to the issues in the application, the outstanding balance of any arrears of rent and costs to be paid by the Tenants to the Landlord shall become immediately due and owing and the Landlord may, without notice to the Tenants, apply to the LTB within 30 days of the Tenants' breach pursuant to section 78 of the *Residential Tenancies Act, 2006 ('RTA')*, for an order terminating the tenancy and evicting the Tenants and requiring that the Tenants pay any new arrears, NSF fees and related charges that become owing after February 28, 2026.
