



**Order under Section 78(6)
Residential Tenancies Act, 2006**

And

Jahzaya Leon Tyrell McFarlane Tenant

WDL 8 LP, c/o Tricon Residential (the 'Landlord') applied for an order to terminate the tenancy and evict Jahzaya Leon Tyrell McFarlane (the 'Tenant') because the Tenant did not meet a condition specified in the order issued by the LTB on July 24, 2025 with respect to application LTB-L-026543-25.

This application was decided without a hearing being held.

Determinations:

1. The order provides that the Landlord can apply to the LTB under section 78 of the *Residential Tenancies Act, 2006* (the 'Act') without notice to the Tenant to terminate the tenancy and evict the Tenant if the Tenant does not meet certain condition(s) in the order. This application was filed within 30 days of the breach.
2. I find that the Tenant has not met the following condition specified in the order:

The Tenant substantially interfered with the reasonable enjoyment of the Landlord and other tenants of the residential complex. Specifically, on February 1 and February 11, 2026 the Tenant could be heard yelling and shouting within their rental unit resulting in multiple complaints. This behaviour is in direct contravention of the conditions imposed in the July 24, 2025 order.

It is ordered that:

1. The tenancy between the Landlord and the Tenant is terminated. The Tenant must move out of the rental unit on or before February 28, 2026.
2. If the unit is not vacated on or before February 28, 2026, then starting March 1, 2026, the Landlord may file this order with the Court Enforcement Office (Sheriff) so that the eviction may be enforced.

3. Upon receipt of this order, the Court Enforcement Office (Sheriff) is directed to give vacant possession of the unit to the Landlord on or after March 1, 2026.
