



Order under Section 69 Residential Tenancies Act, 2006

Between: Ridgford Charitable Foundation Landlord

And

Melissa London Tenant

Ridgford Charitable Foundation (the 'Landlord') applied for an order to terminate the tenancy and evict Melissa London (the 'Tenant') because the Tenant did not pay the rent that the Tenant owes.

The application was scheduled to be heard by video conference on February 19, 2026.

Before the start of the hearing the Landlord's legal representative Emily Barbati and the Tenant Melissa London.

The parties requested that Dispute Resolution Officer (DRO) Diego Fernandez-Stoll provide assistance in finalizing the terms and issue an order on consent to resolve all matters raised in the application. The Tenant spoke with Tenant Duty Counsel before providing their consent to the terms contained herein.

Upon reviewing the terms of the consent with the parties, I was satisfied that the parties understood the terms and consequences of their consent.

The parties agreed that:

1. The total arrears of rent owing up to February 28, 2026, including the application filing fee are \$1,787.00.

It is ordered on consent that:

1. The Tenant shall pay to the Landlord \$1,787.00 for arrears of rent up to February 28, 2026 and costs.
2. The Tenant shall pay to the Landlord the amount set out in paragraph 1 in accordance with the following schedule:
 - a) \$297.83 payable on or before March 12, 2026.
 - b) \$297.83 payable on or before April 12, 2026.

- c) \$297.83 payable on or before May 12, 2026.
 - d) \$297.83 payable on or before June 12, 2026.
 - e) \$297.83 payable on or before July 12, 2026.
 - f) \$297.85 payable on or before August 12, 2026.
3. The Tenant shall also pay to the Landlord new rent on time and in full as it comes due and owing for the period **March 1, 2026**, through to and including **August 1, 2026**, or until the arrears are paid in full, whichever date is earliest.
4. If the Tenant fails to make any one of the payments in accordance with this order, the outstanding balance of any arrears of rent and costs to be paid by the Tenant to the Landlord pursuant to paragraph 1 of this order shall become immediately due and owing and the Landlord may, without notice to the Tenant, apply to the LTB within 30 days of the Tenant's breach pursuant to section 78 of the Act for an order terminating the tenancy and evicting the Tenant and requiring that the Tenant pay any new arrears, NSF fees and related charges that became owing after **February 28, 2026**.
