



**Order under Section 69
Residential Tenancies Act, 2006**

Ranee Management (the 'Landlord') applied for an order to terminate the tenancy and evict Angeli Gem Almonte and Cielo Pearl Almonte (the 'Tenants') because the Tenants did not pay the rent that the Tenants owe.

This application was heard by videoconference on February 19, 2026.

Only the Landlord's Agent, Elizaveta Povargo, attended the hearing.

As of 9:54 a.m., the Tenants were not present or represented at the hearing although properly served with notice of this hearing by the LTB. There was no record of a request to adjourn the hearing. As a result, the hearing proceeded with only the Landlord's evidence.

Determinations:

1. The Landlord served the Tenants with a valid Notice to End Tenancy Early for Non-payment of Rent (N4 Notice). The Tenants did not void the notice by paying the amount of rent arrears owing by the termination date in the N4 Notice or before the date the application was filed.
2. As of the hearing date, the Tenants were still in possession of the rental unit.
3. The lawful rent is \$2,097.88. It is due on the 1st day of each month.
4. Based on the Monthly rent, the daily rent/compensation is \$68.97. This amount is calculated as follows: \$2,097.88 x 12, divided by 365 days.
5. The Tenants have not made any payments since the application was filed.
6. The rent arrears owing to February 28, 2026, are \$12,445.72.

7. The Landlord incurred costs of \$186.00 for filing the application and is entitled to reimbursement of those costs.
8. The Landlord collected a rent deposit of \$2,097.88 from the Tenants and this deposit is still being held by the Landlord. The rent deposit can only be applied to the last rental period of the tenancy if the tenancy is terminated.
9. Interest on the rent deposit, in the amount of \$28.24 is owing to the Tenants for the period from July 1, 2025, to February 19, 2026.
10. The Landlords sought a termination of the tenancy due to the rental arrears owing. The Tenants did not attend the hearing to provide submissions regarding their circumstances and the Landlords' Agent was unaware of any circumstances to consider with respect to relief from eviction.
11. I have considered all of the disclosed circumstances in accordance with subsection 83(2) of the Residential Tenancies Act, 2006 (the 'Act'), including whether the Landlord attempted to negotiate a repayment agreement with the Tenants and find that it would be unfair to grant relief from eviction pursuant to subsection 83(1) of the Act.

It is ordered that:

1. The tenancy between the Landlord and the Tenants is terminated unless the Tenants void this order.
 2. **The Tenants may void this order and continue the tenancy by paying to the Landlord or to the LTB in trust:**
 - \$12,631.72 if the payment is made on or before February 28, 2026. See Schedule 1 for the calculation of the amount owing.
- OR**
- \$14,729.60 if the payment is made on or before March 8, 2026. See Schedule 1 for the calculation of the amount owing.
 3. The Tenants may also make a motion at the LTB to void this order under section 74(11) of the Act, if the Tenants have paid the full amount owing as ordered plus any additional rent that became due after March 8, 2026, but before the Court Enforcement Office (Sheriff) enforces the eviction. The Tenants may only make this motion once during the tenancy.
 4. **If the Tenants do not pay the amount required to void this order the Tenants must move out of the rental unit on or before March 8, 2026.**
 5. If the Tenants do not void the order, the Tenants shall pay to the Landlord \$9,718.15. This amount includes rent arrears owing up to the date of the hearing and the cost of filing the application. The rent deposit and interest the Landlord owes on the rent deposit are deducted from the amount owing by the Tenants. See Schedule 1 for the calculation of the amount owing.

6. The Tenants shall also pay the Landlord compensation of \$68.97 per day for the use of the unit starting February 20, 2026, until the date the Tenants move out of the unit.
7. If the Tenants do not pay the Landlord the full amount owing on or before March 8, 2026, the Tenants will start to owe interest. This will be simple interest calculated from March 9, 2026, at 4.00% annually on the balance outstanding.
8. If the unit is not vacated on or before March 8, 2026, then starting March 9, 2026, the Landlord may file this order with the Court Enforcement Office (Sheriff) so that the eviction may be enforced.
9. Upon receipt of this order, the Court Enforcement Office (Sheriff) is directed to give vacant possession of the unit to the Landlord on or after March 9, 2026.

B. Amount the Tenants must pay to void the eviction order and continue the tenancy if the payment is made on or before March 8, 2026.

Application Filing Fee	\$186.00
Total the Tenants must pay to continue the tenancy	\$14,729.60

C. Amount the Tenants must pay if the tenancy is terminated.

Rent Owing to Hearing Date	\$11,658.27
Application Filing Fee	\$186.00
Less the amount of the last month's rent deposit	- \$2,097.88
Less the amount of the interest on the last month's rent deposit	- \$28.24
Total amount owing to the Landlord	\$9,718.15
Plus, daily compensation owing for each day of occupation starting February 20, 2026	\$68.97 (per day)
**Ongoing daily compensation continues to accumulate until the total amount owing (excluding costs) is \$50,000.00.
