



**Order under Section 69
Residential Tenancies Act, 2006**

And

CHACK MBIDI Tenant

LES CENTRES D'ACCUEIL HÉRITAGE (the 'Landlord') applied for an order to terminate the tenancy and evict CHACK MBIDI (the 'Tenant') because the Tenant did not pay the rent that the Tenant owes.

This application was scheduled to be heard by videoconference on February 24, 2026.

The Landlord, represented by Assiatou Sale and the Tenant engaged in mediation with Dispute Resolution Officer, Cheryl Lavoie. As a result of the resolution discussion, the parties reached a settlement of all issues arising from the Application up to the date of the hearing.

The parties before the LTB consented to the following order:

It is ordered on consent that:

1. The Tenant shall pay to the Landlord \$5,322.02 for arrears of rent up to February 28, 2026.
2. The Tenant shall pay to the Landlord the amount set out in paragraph 1 in accordance with the following schedule:
 - a) \$550.00 on or before March 6, 2026.
 - b) \$1,000.00 on or before March 20, 2026.
 - c) \$550.00 on or before April 3, 2026.
 - d) \$1,000.00 on or before April 17, 2026.
 - e) \$550.00 on or before May 1, 2026.
 - f) \$550.00 on or before May 15, 2026.
 - g) \$550.00 on or before May 29, 2026.
 - h) \$572.02 on or before June 12, 2026.
3. The Tenant shall also pay to the Landlord new rent on time and in full as it comes due and owing for the period March 1, 2026, to June 1, 2026, or until the arrears are paid in full, whichever date is earliest.

4. If the Tenant fails to make any one of the payments in accordance with this order, the outstanding balance of any arrears of rent and costs to be paid by the Tenant to the Landlord pursuant to paragraph 1 of this order shall become immediately due and owing and the Landlord may, without notice to the Tenant, apply to the LTB within 30 days of the Tenant's breach pursuant to section 78 of the Act for an order terminating the tenancy and evicting the Tenant and requiring that the Tenant pay any new arrears, NSF fees and related charges that became owing after February 28, 2026.
