



Order under Section 21.2 of the Statutory Powers Procedure Act and the Residential Tenancies Act, 2006

Review Order

SKPM Rents 4 (the 'Landlord') applied for an order to terminate the tenancy and evict BARBARA ZALESKI (the 'Tenant') because the Tenant did not pay the rent that the Tenant owes.

The Landlord also claimed charges related to NSF cheques.

This application was resolved by order LTB-L-074687-25 issued on November 27, 2025.

On January 28, 2026, the Tenant requested a review of the order and that the order be stayed until the request to review the order is resolved.

On January 29, 2026 interim order LTB-L-074687-25-RV-IN was issued, staying the order issued on November 27, 2025.

This request was heard by videoconference on February 24, 2026.

The Landlord's Legal Representative, S. Ginman, the Tenant, and the Tenant's Support, Zoland Quadros (EPIC), attended the hearing.

The parties before the LTB consented to the following order.

On consent, it is ordered that:

1. The request to review order LTB-L-074687-25 issued on November 27, 2025 is granted. The order is cancelled and replaced by the following:
2. The tenancy between the Landlord and the Tenant is terminated unless the Tenant voids this order.
3. **The Tenant may void this order and continue the tenancy by paying to the Landlord or to the LTB in trust:**

- \$1,750.00 if the payment is made on or before February 28, 2026. See Schedule 1 for the calculation of the amount owing.

OR

- \$3,535.45 if the payment is made on or before March 15, 2026. See Schedule 1 for the calculation of the amount owing.
4. The Tenant may also make a motion at the LTB to void this order under section 74(11) of the Act, if the Tenant has paid the full amount owing as ordered plus any additional rent that became due after March 15, 2026 but before the Court Enforcement Office (Sheriff) enforces the eviction. The Tenant may only make this motion once during the tenancy.
 5. **If the Tenant does not pay the amount required to void this order the Tenant must move out of the rental unit on or before March 15, 2026.**
 6. As of the date of the hearing, the amount of the rent deposit and interest the Landlord owes on the rent deposit exceeds the arrears of rent, compensation and the cost of filing the application the Landlord is entitled to by \$325.73. See Schedule 1 for the calculation of the amount owing. However, the Landlord is authorized to deduct from the amount owing to the Tenant \$58.70 per day for compensation for the use of the unit starting February 25, 2026 until the date the Tenant moves out of the unit.
 7. The Landlord or the Tenant shall pay to the other any sum of money that is owed as a result of this order.
 8. If the unit is not vacated on or before March 15, 2026, then starting March 16, 2026, the Landlord may file this order with the Court Enforcement Office (Sheriff) so that the eviction may be enforced.
 9. Upon receipt of this order, the Court Enforcement Office (Sheriff) is directed to give vacant possession of the unit to the Landlord on or after March 16, 2026.
