



**Order under Section 69
Residential Tenancies Act, 2006**

2363753 ONTARIO INC (the 'Landlord') applied for an order to terminate the tenancy and evict MILTON PADILLA, YESENIA CORDERO and WENDY CORDERO (the 'Tenants') because the Tenants did not pay the rent that the Tenants owe.

This application was mediated by videoconference on February 25, 2026. Paralegal, James Moak, attended on behalf of the Landlord. The Tenants attended. The parties reached settlement and requested a consent order. I was satisfied the parties made informed decisions, understanding the terms and consequences.

General Information:

1. The Landlord served the Tenants with a Notice to End Tenancy Early for Non-payment of Rent (N4). The Tenants did not void the notice by paying the amount of rent arrears owing by the termination date in the notice or before the day the application was filed.
2. As of the hearing date, the Tenants were still in possession of the rental unit.
3. The current rent is \$2,124.15. It is due on the 1st day of each month.
4. The rent arrears owing to February 28, 2026 are \$13,112.90.
5. The Landlord incurred costs of \$186.00 for filing the application and is entitled to reimbursement of those costs.
6. Accordingly, the total amount the Tenants owe the Landlord is \$13,298.90 (\$13,112.90 + \$186.00).

7. Pursuant to section 78, the parties agree on a payment plan.

On consent, it is ordered that:

1. The Tenants shall pay to the Landlord \$13,112.90 for arrears of rent up to February 28, 2026 and \$186.00 costs, totalling \$13,298.90.
2. The Tenants shall pay to the Landlord the amount set out in paragraph 1 (\$13,298.00) in accordance with the following schedule:
 - . \$738.82 minimum on or before the 20th of each month from

March 20, 2026 to July 20, 2027 (11 months) and
 - . \$738.96 on or before August 20, 2027.
3. The Tenants shall also pay to the Landlord new rent for March 2026 by March 6, 2026 and for the period April 1, 2026 to August 31, 2027 on or before the 1st of each month or until the arrears are paid in full, whichever date is earliest.
4. If the Tenants fail to make any one of the payments in accordance with this order, the outstanding balance of any arrears of rent and costs to be paid by the Tenant to the Landlord pursuant to paragraph 1 of this order shall become immediately due and owing and the Landlord may, without notice to the Tenants, apply to the LTB within 30 days of the Tenants' breach pursuant to section 78 of the Act for an order terminating the tenancy and evicting the Tenant and requiring that the Tenant pay any new arrears, NSF fees and related charges that became owing after May 1, 2027.
