



**Order under Section 78(6)
Residential Tenancies Act, 2006**

Morguard Corporation (the 'Landlord') applied for an order to terminate the tenancy and evict Athika Fatima and Piyush Meherchchandani (the 'Tenants') because the Tenants did not meet a condition specified in the order issued by the LTB on January 13, 2026, with respect to application LTB-L-091203-25.

This application was decided without a hearing being held.

Determinations:

1. The order provides that the Landlord can apply to the LTB under section 78 of the *Residential Tenancies Act, 2006* (the 'Act') without notice to the Tenants to terminate the tenancy and evict the Tenants if the Tenants do not meet certain condition(s) in the order. This application was filed within 30 days of the breach.

2. I find that the Tenants have not met the following condition specified in the order:

The Tenants failed to pay to the Landlord the lawful rent of \$2,645.11 in full due on February 1, 2026.

3. This order replaces order LTB-L-091203-25.
4. The Landlord collected a rent deposit of \$2,645.11 from the Tenants and this deposit is still being held by the Landlord.
5. Interest on the rent deposit is owing to the Tenants for the period from January 1, 2026, to March 2, 2026.
6. The amount of the rent deposit and interest on the rent deposit is applied to the amount the Tenants is required to pay.

7. The Landlord is entitled to daily compensation from the day after this order is issued to the date the Tenants move out of the unit at a daily rate of \$86.96. This amount is calculated as follows: \$2,645.11 x 12, divided by 365 days.

It is ordered that:

1. Order LTB-L-091203-25 is cancelled.
2. The tenancy between the Landlord and the Tenants is terminated. The Tenants must move out of the rental unit on or before March 13, 2026.
3. If the unit is not vacated on or before March 13, 2026, then starting March 14, 2026, the Landlord may file this order with the Court Enforcement Office (Sheriff) so that the eviction may be enforced.
4. Upon receipt of this order, the Court Enforcement Office (Sheriff) is directed to give vacant possession of the unit to the Landlord on or after March 14, 2026.
5. As of the date of this order, the amount of the rent deposit and interest the Landlord owes on the rent deposit exceeds the amount the Landlord is entitled to by \$2,654.39.
6. However, the Landlord is authorized to deduct the following from the amount the Landlord owes the Tenants: \$86.96 per day for compensation for the use of the unit starting March 3, 2026, to the date the Tenants move out of the unit.
7. The Landlord or the Tenants shall pay to the other any sum of money that is owed as a result of this order.
