



Order under Section 69 Residential Tenancies Act, 2006

In the matter of: 105-2356 Islington Ave.
Etobicoke, ON M9W3X3

Between: Islington Apartments Inc. Landlord

And

Fransisco Cordoba Tenant

Islington Apartments Inc. (the 'Landlord') applied for an order to terminate the tenancy and evict Fransisco Cordoba (the 'Tenant') because the Tenant did not pay the rent owed.

The Landlord also claimed charges related to NSF cheques.

This application was heard by videoconference on March 5, 2026.

Only the Landlord's Agent, Joseph Hacoheh, attended the hearing.

As of 9:23 a.m., the Tenant was not present or represented at the hearing although properly served with notice of this hearing by the LTB. There was no record of a request to adjourn the hearing. As a result, the hearing proceeded with only the Landlord's evidence.

Determinations:

1. The Landlord served the Tenant with a valid Notice to End Tenancy Early for Non-payment of Rent (N4 Notice). The Tenant did not void the notice by paying the amount of rent arrears owing by the termination date in the N4 Notice or before the date the application was filed.
2. The Tenant was in possession of the rental unit on the date the application was filed.
3. The Tenant vacated the rental unit on January 26, 2026. Rent arrears are calculated up to the date the Tenant vacated the unit.
4. The lawful rent is \$1,279.07. It was due on the 1st day of each month.

5. The Tenant has paid \$2,576.83 to the Landlord since the application was filed.
6. The rent arrears owing to January 26, 2026, are \$(230.77).
7. The Landlord is entitled to \$36.00 to reimburse the Landlord for administration charges and \$14.00 for bank fees the Landlord incurred as a result of 2 cheques given by or on behalf of the Tenant which were returned NSF.
8. The Landlord incurred costs of \$186.00 for filing the application and is entitled to reimbursement of those costs.
9. There is no last month's rent deposit.

It is ordered that:

1. The tenancy between the Landlord and the Tenant is terminated as of January 26, 2026, the date the Tenant moved out of the rental unit.
2. The Tenant shall pay to the Landlord \$5.23. This amount includes rent arrears owing up to the date the Tenant moved out of the rental unit and the cost of filing the application and unpaid NSF charges. See Schedule 1 for the calculation of the amount owing.
3. If the Tenant does not pay the Landlord the full amount owing on or before March 21, 2026, the Tenant will start to owe interest. This will be simple interest calculated from March 22, 2026, at 4.00% annually on the balance outstanding.
