



**Order under Section 69
Residential Tenancies Act, 2006**

Between: PARK PROPERTY MANAGEMENT INC. Landlord

And

Galib Peermohamed Tenant

PARK PROPERTY MANAGEMENT INC. (the 'Landlord') applied for an order to terminate the tenancy and evict Galib Peermohamed (the 'Tenant') because the Tenant did not pay the rent that the Tenant owes.

This application was heard by videoconference on March 4, 2026. Paralegal, Anita Sada, attended on behalf of the Landlord. The Tenant authorized his brother, Karim Peermohamed, to attend. Written authorization was filed. The parties reached a settlement and requested a consent order. I was satisfied made informed decisions, understanding the terms and consequences.

General Information:

1. The Landlord served the Tenant with a Notice to End Tenancy Early for Non-payment of Rent (N4). The Tenant did not void the notice by paying the amount of rent arrears owing by the termination date in the notice or before the day the application was filed.
2. As of the hearing date, the Tenant was still in possession of the rental unit.
3. The current rent is \$1,798.17. It is due on the 1st day of each month.
4. The rent arrears owing to March 31, 2026 are \$5,389.02.
5. The Landlord incurred costs of \$186.00 for filing the application and is entitled to reimbursement of those costs.
6. Accordingly, the total amount the Tenant owes the Landlord is \$5,575.02 (\$5,389.02 + \$186.00).
7. Pursuant to section 78 of the Act, the parties agree on a payment plan.

On Consent, it is ordered that:

1. The Tenant shall pay to the Landlord \$5,389.02 for arrears of rent up to March 31, 2026 and \$186.00 costs, totalling \$5,575.02.
2. The Tenant shall pay to the Landlord the amount set out in paragraph 1 (\$5,575.02) in accordance with the following schedule:
 - . \$1,798.17 minimum on or before March 21, 2026.
 - . \$945.00 minimum on or before the 25th of each month for April, May and June 2026.
 - . \$941.85 on or before July 25, 2026.
3. The Tenant shall also pay to the Landlord new rent on time and in full as it comes due and owing for the period April 1, 2026 to July 31, 2026, or until the arrears are paid in full, whichever date is earliest.
4. If the Tenant fails to make any one of the payments in accordance with this order, the outstanding balance of any arrears of rent and costs to be paid by the Tenant to the Landlord pursuant to paragraph 1 of this order shall become immediately due and owing and the Landlord may, without notice to the Tenant, apply to the LTB within 30 days of the Tenant's breach pursuant to section 78 of the Act for an order terminating the tenancy and evicting the Tenant and requiring that the Tenant pay any new arrears, NSF fees and related charges that became owing after August 1, 2026.
