



**Order under Section 69
Residential Tenancies Act, 2006**

Greenwin Corp (the 'Landlord') applied to the Landlord and Tenant Board ('LTB') for an order to terminate the tenancy and evict ELEAH GARNETT, ANNIE JACOBS and MARCUS DUBLIN (the 'Tenants') because the Tenants did not pay the rent that the Tenants owe.

This application was scheduled to be heard by videoconference on March 9, 2026. Matt Anderson, licenced paralegal, represented the Landlord. Marcus Dublin attended on behalf of all the Tenants.

The parties resolved the application on their own and requested the LTB issue an Order on consent confirming their agreement. I, as Dispute Resolution Officer and Hearing Officer, am satisfied that the parties understood the terms of their consent as set out in the Order below.

It is ordered on consent that:

1. The Tenants shall pay to the Landlord \$5,498.37. This amount represents \$5,312.37 for arrears of rent up to March 31, 2026, and the \$186.00 application filing fee (costs).
2. The Tenants shall pay to the Landlord the amount set out in paragraph 1 in accordance with the following schedule:

April 17, 2026	\$800.00

May 17, 2026	\$800.00
June 17, 2026	\$800.00
July 17, 2026	\$800.00
August 17, 2026	\$800.00
September 17, 2026	\$698.37

3. The Tenants shall also pay to the Landlord the lawful monthly rent on or before the 1st day of each month starting April 2026 through to and including September 2026, or until the arrears are paid in full, whichever date is earliest.
4. If the Tenants fail to make any of the payments in accordance with this order, the outstanding balance of any arrears of rent and costs to be paid by the Tenants to the Landlord pursuant to paragraph 1 of this order shall become immediately due and owing and the Landlord may, without notice to the Tenants, apply to the LTB within 30 days of the Tenants' breach pursuant to section 78 of the Act for an order terminating the tenancy and evicting the Tenants and requiring that the Tenants pay any new arrears, NSF fees and related charges that became owing after March 31, 2026.
