Residential Tenancies Act, 2006**

668308 Ontario Limited (the 'Landlord') applied for an order to terminate the tenancy and evict Evyn William Chambers and William Ryckman (the 'Tenants') and for an order to have the Tenants pay the rent they owe because the Tenants did not meet a condition specified in the order issued by the LTB on May 13, 2025, with respect to application LTB-L-007594-25.

The Landlord's application was resolved by order LTB-L-105991-25, issued on January 7, 2026. This order was issued without a hearing being held.

The Tenant filed a motion to set aside order LTB-L-105991-25.

This motion was heard by videoconference on March 4, 2026.

The Landlord Legal Representative Carrie Allen and the Tenant Evyn William Chambers attended on behalf of both tenants.

The parties requested that Dispute Resolution Officer (DRO) Jennifer Buckminster provide assistance in finalizing the terms and issue an order on consent to resolve all matters raised in the application.

Upon reviewing the terms of the consent with the parties, I was satisfied that the parties understood the terms and consequences of their consent.

It is ordered on consent that:

1. The motion to set aside Order LTB-L-105991-25, issued on March 13, 2026, is granted.
2. Order LTB-L-105991-25, issued on January 7, 2026, is set aside and cannot be enforced.

3. The previous order issued on May 13, 2025, with respect to LTB-L-007594-25 is cancelled and replaced with the following:
4. The Tenants shall pay to the Landlord \$6623.13 for arrears of rent owing up to March 31, 2026.
5. The Tenants shall pay to the landlord the amount set out in paragraph 4 in accordance with the following schedule:

April 15, 2026	\$212.23
May 15, 2026	\$212.18
June 15, 2026	\$212.18
July 15, 2026	\$212.18
August 15, 2026	\$212.18

6. The Tenants shall also pay to the Landlord new rent on time and in full as it comes due and owing for the period April 1, 2026, to September 1, 2026, or until the arrears are paid in full, whichever date is earliest.
7. If the Tenants fail to make any one of the payments in accordance with this order, the outstanding balance of any arrears of rent and costs to be paid by the Tenants to the Landlord pursuant to paragraph #4 #5 #6 of this order shall become immediately due and owing and the Landlord may, without notice to the Tenants, apply to the LTB within 30 days of the Tenant's breach pursuant to section 78 of the Act for an order terminating the tenancy and evicting the Tenant and requiring that the Tenants pay any new arrears, NSF fees and related charges that became owing after date arrears run to.
