



**Order under Section 69  
Residential Tenancies Act, 2006**

**In the matter of:** 5, 145 ARLINGTON AVE

**Between:** Akelius Canada Ltd. Landlord

**And**

Curtis White Tenant

Akelius Canada Ltd. (the 'Landlord') applied for an order to terminate the tenancy and evict Curtis White (the 'Tenant') because the Tenant did not pay the rent that the Tenant owes.

This application was scheduled to be heard by videoconference on March 5, 2026.

The Landlord's Representative, Sabrina Marchionne, and the Tenant attended.

The parties mutually agreed to resolve all the issues in the application and requested an order on consent confirming their agreement. I am satisfied that the parties understood the terms and consequences of their consent as set out in the order below.

**The Parties agree that:**

1. The lawful rent is \$1,750.00. It is due on the 1st day of each month.
2. Based on the Monthly rent, the daily rent/compensation is \$57.53. This amount is calculated as follows: \$1,750.00 x 12, divided by 365 days.
3. The rent arrears owing to March 31, 2026, are \$10,450.00.
4. The Landlord incurred costs of \$186.00 for filing the application and is entitled to reimbursement of those costs.
5. There is no last month's rent deposit.

**It is ordered on consent that:**

1. The tenancy between the Landlord and the Tenant is terminated unless the Tenant voids this order.

**2. The Tenant may void this order and continue the tenancy by paying to the Landlord or to the LTB in trust:**

- \$10,636.00 if the payment is made on or before March 31, 2026. See Schedule 1 for the calculation of the amount owing.

**OR**

- \$12,386.00 if the payment is made on or before April 30, 2026. See Schedule 1 for the calculation of the amount owing.
3. The Tenant may also make a motion at the LTB to void this order under section 74(11) of the Act, if the Tenant has paid the full amount owing as ordered plus any additional rent that became due after April 30, 2026, but before the Court Enforcement Office (Sheriff) enforces the eviction. The Tenant may only make this motion once during the tenancy.
4. **If the Tenant does not pay the amount required to void this order the Tenant must move out of the rental unit on or before April 30, 2026.**
5. If the Tenant does not void the order, the Tenant shall pay to the Landlord \$9,173.65. This amount includes rent arrears owing up to the date of the hearing and the cost of filing the application. See Schedule 1 for the calculation of the amount owing.
6. The Tenant shall also pay the Landlord compensation of \$57.53 per day for the use of the unit starting March 6, 2026, until the date the Tenant moves out of the unit.
7. If the Tenant does not pay the Landlord the full amount owing on or before April 30, 2026, the Tenant will start to owe interest. This will be simple interest calculated from May 1, 2026, at 4.00% annually on the balance outstanding.
8. If the unit is not vacated on or before April 30, 2026, then starting May 1, 2026, the Landlord may file this order with the Court Enforcement Office (Sheriff) so that the eviction may be enforced.
9. Upon receipt of this order, the Court Enforcement Office (Sheriff) is directed to give vacant possession of the unit to the Landlord on or after May 1, 2026.
