



**Order under Section 69
Residential Tenancies Act, 2006**

Toronto Community Housing (the 'Landlord') applied for an order to terminate the tenancy and evict Nigar Nahar (the 'Tenant') because the Tenant did not pay the rent that the Tenant owes.

The application was resolved by Order LTB-L-097211-25 on February 9, 2026.

On February 12, 2026, LTB-L-097211-25-RV-IN was issued stating that the Order is stayed and the LTB would schedule a hearing on the Tenant's request to review.

The application was scheduled to be heard by video conference on March 16, 2026. The Landlord's Agent, Irma Halili attended. The Tenant was also in attendance with her legal representative, Ricardo Colonnese. Interpreter Anisur Rahman Gazi attended to assist the Tenant with interpretation services. Prior to the hearing, the parties elected to participate in LTB facilitated mediation with the assistance of Helen Giannini, a Dispute Resolution Officer and Hearing Officer, with the Landlord and Tenant Board. As a result of the resolution discussion, the parties mutually agreed to resolve all matters at issue in the application and requested an order on consent. I was satisfied that the parties understood the terms and consequences of their consent.

The Parties agreed:

- a. The request to review Order LTB-L-097211-25, issued on February 9, 2026, is granted.
- b. Order LTB-L-097211-25 issued on February 9, 2026, is cancelled and replaced with this Order.

- c. The Landlord served the Tenant with a Notice to End Tenancy Early for Non-payment of Rent (N4). The Tenant did not void the notice by paying the amount of rent arrears owing by the termination date in the notice or before the day the application was filed.
- d. As of the hearing date, the Tenant was still in possession of the rental unit.
- e. The current lawful rent is \$1,856.00. The rent is due on the 1st day of each month.
- f. The rent arrears owing by the Tenant up to and including March 31, 2026, including the \$186.00 application filing fee are \$23,623.00.

It is ordered on consent that:

- 1. The Tenant shall pay to the Landlord \$23,623.00 for arrears of rent up to March 31, 2026, including the application filing fee.
- 2. The Tenant shall pay to the Landlord the amount set out in paragraph 1 through a payment plan, whereby the Tenant will pay the Landlord \$280.00 a month, on or before the 10th of each month, beginning on April 10, 2026, until the arrears are paid in full.
- 3. The Tenant shall also pay to the Landlord new rent on time and in full as it comes due and owing for the period, of and including April 1, 2026, to September 1, 2034, or until the arrears are paid in full, whichever date is earliest.
- 4. If the Tenant fails to make any one of the payments in accordance with this order, the outstanding balance of any arrears of rent and costs to be paid by the Tenant to the Landlord pursuant to paragraph 1 of this order shall become immediately due and owing and the Landlord may, without notice to the Tenant, apply to the LTB within 30 days of the Tenant's breach pursuant to section 78 of the Act for an order terminating the tenancy and evicting the Tenant and requiring that the Tenant pay any new arrears, NSF fees and related charges that became owing after March 31, 2026.
