



**Order under Section 69
Residential Tenancies Act, 2006**

SOFIA CANAYON Tenant

2491364 ONTARIO INC (the 'Landlord') applied for an order to terminate the tenancy and evict SOFIA CANAYON (the 'Tenant') because the Tenant did not pay the rent that the Tenant owes.

The application was scheduled to be heard by video conference on March 17, 2026.

Before the start of the hearing the Landlord's legal representative Jason Paine and the Tenant Sofia Canayon engaged in private settlement discussions and advised that the parties had reached an agreement.

The parties requested that Dispute Resolution Officer (DRO) Diego Fernandez-Stoll provide assistance in finalizing the terms and issue an order on consent to resolve all matters raised in the application.

Upon reviewing the terms of the consent with the parties, I was satisfied that the parties understood the terms and consequences of their consent.

The parties agreed that:

1. The lawful rent is \$2,306.25. It is due on the 1st day of month.
2. Based on the Monthly rent, the daily rent/compensation is \$75.82. This amount is calculated as follows: $\$2,306.25 \times 12$, divided by 365 days.
3. The Tenant has paid \$4,709.36 to the Landlord since the application was filed.
4. The rent arrears owing to March 31, 2026, are \$4,515.58.
5. The Tenant shall pay the Landlord incurred costs of \$186.00 for filing the application.

6. The Landlord collected a rent deposit of \$2,306.25 from the Tenant and this deposit is still being held by the Landlord. The rent deposit shall be applied to the last rental period of the tenancy.
7. Interest on the rent deposit, in the amount of \$5.97 is owing to the Tenant for the period from February 1, 2026 to March 17, 2026.

On consent of the parties, it is ordered that:

1. The tenancy between the Landlord and the Tenant is terminated unless the Tenant voids this order.
 2. **The Tenant may void this order and continue the tenancy by paying to the Landlord or to the LTB in trust:**
 - \$4,701.58 if the payment is made on or before March 31, 2026. See Schedule 1 for the calculation of the amount owing.
- OR**
- \$7,007.83 if the payment is made on or before April 24, 2026. See Schedule 1 for the calculation of the amount owing.
 3. The Tenant may also make a motion at the LTB to void this order under section 74(11) of the Act, if the Tenant has paid the full amount owing as ordered plus any additional rent that became due after April 24, 2026 but before the Court Enforcement Office (Sheriff) enforces the eviction. The Tenant may only make this motion once during the tenancy.
 4. **If the Tenant does not pay the amount required to void this order the Tenant must move out of the rental unit on or before April 24, 2026**
 5. If the Tenant does not void the order, the Tenant shall pay to the Landlord \$1,372.05. This amount includes rent arrears owing up to the date of the agreement and the cost of filing the application. The rent deposit and interest the Landlord owes on the rent deposit are deducted from the amount owing by the Tenant. See Schedule 1 for the calculation of the amount owing.
 6. The Tenant shall also pay the Landlord compensation of \$75.82 per day for the use of the unit starting March 18, 2026 until the date the Tenant moves out of the unit.
 7. If the Tenant does not pay the Landlord the full amount owing on or before April 24, 2026, the Tenant will start to owe interest. This will be simple interest calculated from April 25, 2026 at 4.00% annually on the balance outstanding.
 8. If the unit is not vacated on or before April 24, 2026, then starting April 25, 2026, the Landlord may file this order with the Court Enforcement Office (Sheriff) so that the eviction may be enforced.

9. Upon receipt of this order, the Court Enforcement Office (Sheriff) is directed to give vacant possession of the unit to the Landlord on or after April 25, 2026.
