



**Order under Section 69
Residential Tenancies Act, 2006**

In the matter of: 708, 7 ROANOKE RD

Between: CAPREIT LIMITED PARTNERSHIP Landlord

And

VLAD GABRIEL ISTOK Tenant

CAPREIT LIMITED PARTNERSHIP (the 'Landlord') applied for an order to terminate the tenancy and evict VLAD GABRIEL ISTOK (the 'Tenant') because the Tenant did not pay the rent that the Tenant owes.

This application was to be heard by videoconference on March 26, 2026. The Landlord's representative, Jason Paine, and the Tenant Vlad Gabriel Istok attended the hearing. The Tenant did not speak with Tenant Duty Counsel before the start of mediation.

The parties elected to participate in Board facilitated mediation with the assistance of Dispute Resolution Officer (DRO) John Russett. The parties agreed to resolve the issues in the Landlord's application and requested the LTB to issue a Consent Order confirming their agreement.

I was satisfied that the parties understood the consequences of the Consent.

The parties agree that:

1. As of the hearing date, the Tenant was still in possession of the rental unit.
2. The lawful rent is \$2,160.00. It is due on the 1st day of each month.
3. The Tenant has not made any payments since the application was filed.
4. The rent arrears owing to March 31, 2026 are \$8,640.00.

It is ordered on consent that:

1. The Tenant shall pay to Landlord \$8,826.00 for arrears of rent to March 31, 2026 which includes the application filing fee of \$186.00.

2. The Tenant shall pay to the Landlord the amount set out in paragraph 1 in accordance with the following schedule:
 - a. \$2,000.00 on or before the fifteenth (15) day of each month starting April 15, 2026 for a period Four (4) consecutive months until July 15, 2026; and
 - b. The balance outstanding of \$826.00 on or before August 15, 2026.
3. The Tenant shall also pay to the Landlord new rent on time and in full as it comes due and owing for the period April 1, 2026, to August 1, 2026 or until the arrears are paid in full, whichever date is earliest.
4. If the Tenant fails to make any one of the payments in accordance with paragraphs 2 or 3 of this order, the outstanding balance of any arrears of rent and costs to be paid by the Tenant to the Landlord pursuant to paragraph 1 of this order shall become immediately due and owing and the Landlord may, without notice to the Tenant apply to the Landlord and Tenant Board within 30 days of the Tenant's breach pursuant to section 78 of the Act for an order terminating the tenancy and evicting the Tenant and requiring that the Tenant to pay any new arrears, NSF fees and related charges that became owing after March 31, 2026.
