



**Order under Section 69
Residential Tenancies Act, 2006**

And

KIDUS BAYISSA Tenant

CAPREIT LIMITED PARTNERSHIP (the 'Landlord') applied for an order to terminate the tenancy and evict KIDUS BAYISSA (the 'Tenant') because the Tenant did not pay the rent that the Tenant owes.

This application was heard by videoconference on March 23, 2026.

The Landlord's legal representative Jason Paine and the Tenant attended the hearing.

Determinations:

1. The Landlord served the Tenant with a valid Notice to End Tenancy Early for Non-payment of Rent (N4 Notice). The Tenant did not void the notice by paying the amount of rent arrears owing by the termination date in the N4 Notice or before the date the application was filed.
2. As of the hearing date, the Tenant was still in possession of the rental unit.
3. The lawful rent is \$1,435.36. It is due on the 1st day of each month.
4. Based on the Monthly rent, the daily rent/compensation is \$47.19. This amount is calculated as follows: \$1,435.36 x 12, divided by 365 days.
5. The Tenant has not made any payments since the application was filed.
6. The rent arrears owing to March 31, 2026 are \$5,791.37. This amount was not in dispute.
7. The Landlord incurred costs of \$186.00 for filing the application and is entitled to reimbursement of those costs.
8. There is no last month's rent deposit.

Relief from Eviction

9. The Tenant testified that they have resided in the rental unit for six years and request that the Board order a payment plan requiring monthly payments of \$200.00 toward the arrears, in addition to the regular rent being paid on time.
10. The Tenant stated that he unexpectedly lost his job in March 2026, having previously lost his second source of employment in October 2025. He resides with a roommate who contributes \$700.00 per month, and he receives \$750.00 per month from Ontario Works. The Tenant further testified that he anticipates receiving approximately \$4,000.00 from his tax return and believes he can manage monthly arrears payments of \$200.00. No supplemental evidence was submitted by the Tenant to support his oral testimony.
11. I have considered all of the disclosed circumstances in accordance with subsection 83(2) of the Residential Tenancies Act, 2006 (the "Act"), and I find that it would be unfair to grant relief from eviction pursuant to subsection 83(1) of the Act.
12. The Tenant's monthly income totals \$1,450.00, while the monthly rent alone is \$1,435.36. It is unclear how the Tenant could meet both the ongoing rent obligations and an additional \$200.00 arrears payment given that his income is insufficient. Moreover, the Tenant acknowledged during his testimony that he is unable to pay the April 2026 rent on time. I am not persuaded that the Tenant would be able to comply with a payment plan if one were ordered, and it is evident that the tenancy is no longer viable.

It is ordered that:

1. The tenancy between the Landlord and the Tenant is terminated unless the Tenant voids this order.
2. **The Tenant may void this order and continue the tenancy by paying to the Landlord or to the LTB in trust:**
 - \$5,977.37 if the payment is made on or before March 31, 2026. See Schedule 1 for the calculation of the amount owing.
- OR**
- \$7,412.73 if the payment is made on or before April 7, 2026. See Schedule 1 for the calculation of the amount owing.
3. The Tenant may also make a motion at the LTB to void this order under section 74(11) of the Act, if the Tenant has paid the full amount owing as ordered plus any additional rent that became due after April 7, 2026 but before the Court Enforcement Office (Sheriff) enforces the eviction. The Tenant may only make this motion once during the tenancy.
4. **If the Tenant does not pay the amount required to void this order the Tenant must move out of the rental unit on or before April 7, 2026.**

5. If the Tenant does not void the order, the Tenant shall pay to the Landlord \$5,627.38. This amount includes rent arrears owing up to the date of the hearing and the cost of filing the application. See Schedule 1 for the calculation of the amount owing.
6. The Tenant shall also pay the Landlord compensation of \$47.19 per day for the use of the unit starting March 24, 2026 until the date the Tenant moves out of the unit.
7. If the Tenant does not pay the Landlord the full amount owing on or before April 7, 2026, the Tenant will start to owe interest. This will be simple interest calculated from April 8, 2026 at 4.00% annually on the balance outstanding.
8. If the unit is not vacated on or before April 7, 2026, then starting April 8, 2026, the Landlord may file this order with the Court Enforcement Office (Sheriff) so that the eviction may be enforced.
9. Upon receipt of this order, the Court Enforcement Office (Sheriff) is directed to give vacant possession of the unit to the Landlord on or after April 8, 2026.

Total the Tenant must pay to continue the tenancy	\$7,412.73

C. Amount the Tenant must pay if the tenancy is terminated

Rent Owing To Hearing Date	\$5,441.38
Application Filing Fee	\$186.00
Total amount owing to the Landlord	\$5,627.38
Plus daily compensation owing for each day of occupation starting March 24, 2026	\$47.19 (per day)
**Ongoing daily compensation continues to accumulate until the total amount owing (excluding costs) is \$50,000.00.
