



## **Order under Section 69 Residential Tenancies Act, 2006**

**In the matter of:** 206-15 Bridesburg Dr.

**Between:** CAPREIT Limited Partnership Landlord

**And**

Al B. Foster Tenant

CAPREIT Limited Partnership (the 'Landlord') applied for an order to terminate the tenancy and evict Al B. Foster (the 'Tenant') because the Tenant did not pay the rent owed.

This application was heard by videoconference on March 25, 2026.

The Landlord's Representative, Jason Paine, and the Tenant attended the hearing.

The Tenant declined to met with Tenant Duty Counsel prior to the commencement of the hearing.

At the hearing the parties consented to the following terms and conditions. I was satisfied that the parties provided informed consent.

**It is ordered on consent that:**

1. The Tenant shall pay to the Landlord \$6,376.96 for arrears of rent up to March 31, 2026, and costs.
2. The Tenant shall pay to the Landlord the amount set out in paragraph 1 in accordance with the following schedule:

| 7                | October 15, 2026                   | \$800.00              | \$776.96       |
| 8                | November 15, 2026                  | \$776.96              | \$0.00         |

3. The Tenant shall also pay to the Landlord new rent on time and in full as it comes due and owing for the period from April 1, 2026, to November 1, 2026, or until the arrears are paid in full, whichever date is earliest.
4. If the Tenant fails to make any one of the payments in accordance with this order, the outstanding balance of any arrears of rent and costs to be paid by the Tenant to the Landlord pursuant to paragraph 1 of this order shall become immediately due and owing and the Landlord may, without notice to the Tenant, apply to the LTB within 30 days of the Tenant's breach pursuant to section 78 of the Act for an order terminating the tenancy and evicting the Tenant and requiring that the Tenant pay any new arrears, NSF fees and related charges that became owing after March 31, 2026.
