



Order under Section 69 Residential Tenancies Act, 2006

In the matter of: 910, 100 YORK GATE BLVD

Between: Elm Place Inc. – 100 York Gate Blvd Landlord

And

ADVIRA PALMER Tenant

Elm Place Inc. – 100 York Gate Blvd (the 'Landlord') applied for an order to terminate the tenancy and evict ADVIRA PALMER (the 'Tenant') because the Tenant did not pay the rent that the Tenant owes.

This application was scheduled to be heard by videoconference on March 26, 2026. The Tenant and the Landlord's Legal Representative, Sylwia McArthur, participated.

Before the start of the hearing the parties advised that they had reached an agreement. As a result of the resolution discussion, the parties mutually agreed to resolve all matters in the application and requested an Order on Consent.

I was satisfied that the parties understood the terms and consequences of their consent.

On consent of the parties, it is ordered that:

1. The tenancy between the Landlord and the Tenants is terminated unless the Tenants void this order.
2. **The Tenants may void this order and continue the tenancy by paying to the Landlord or to the LTB in trust:**
 - **\$3 458.30** if the payment is made on or before April 14, 2026. See Schedule 1 for the calculation of the amount owing.
3. The Tenants may also make a motion at the LTB to void this order under section 74(11) of the Act, if the Tenants have paid the full amount owing as ordered plus any additional rent that became due after April 14, 2026 but before the Court Enforcement Office (Sheriff) enforces the eviction. The Tenants may only make this motion once during the tenancy.
4. **If the Tenants do not pay the amount required to void this order the Tenants must move out of the rental unit on or before April 14, 2026.**

5. If the Tenants do not void the order, the Tenants shall pay to the Landlord \$588.59. This amount includes rent arrears owing up to the date of the hearing (March 26, 2026) and the cost of filing the application. The rent deposit and interest the Landlord owes on the rent deposit are deducted from the amount owing by the Tenants. See Schedule 1 for the calculation of the amount owing.
6. The Tenants shall also pay the Landlord compensation of \$44.68 per day for the use of the unit starting March 27, 2026 until the date the Tenants move out of the unit.
7. If the Tenants do not pay the Landlord the full amount owing on or before April 14, 2026, the Tenants will start to owe interest. This will be simple interest calculated from April 15, 2026 at 4.00% annually on the balance outstanding.
8. If the unit is not vacated on or before April 14, 2026, then starting April 15, 2026, the Landlord may file this order with the Court Enforcement Office (Sheriff) so that the eviction may be enforced.
9. Upon receipt of this order, the Court Enforcement Office (Sheriff) is directed to give vacant possession of the unit to the Landlord on or after April 15, 2026.
