



AMENDED ORDER
Order under Section 69
Residential Tenancies Act, 2006
and Section 21.1 Statutory Powers Procedure Act

William Currie Tenant

Neighbours Community Homes (the 'Landlord') applied for an order to terminate the tenancy and evict William Currie (the 'Tenant') because the Tenant did not pay the rent that the Tenant owes.

This application was mediated by videoconference on March 10, 2026.

The Landlord's Agent, Judy Ngo, attended on behalf of the Landlord.

The Tenant attended with Legal Representative, Dashandeep Saini.

The parties elected to participate in LTB-facilitated mediation with the assistance of Angela McLaughlin, a Dispute Resolution Officer and Hearings Officer with the Landlord and Tenant Board.

This amended order is issued to correct clerical errors in the order issued on March 17, 2026. All corrections are bolded and underlined for ease of reference. The rest of the order remains unchanged.

The parties agree:

1. The lawful monthly rent is **\$300.42**.
2. The total amount the Tenant owes to the Landlord is \$5,495.78 including arrears of rent up to March 31, 2026.
3. The Landlord waives the application filing fee.

On consent of the parties, it is ordered that:

1. The Tenant shall pay to the Landlord \$5,495.78 which represents the arrears of rent outstanding for the period ending March 31, 2026.
2. The Landlord's application for eviction of the Tenant is denied on the condition that:
 - a. The Tenant shall make the following payments to the Landlord in respect of the monies owing under paragraph 1 of this order:

- b. The Tenant shall also pay the Landlord the rent for the months of April 2026 up to and including October 2027 in full, on or before the 1st day of each corresponding month or until the arrears are paid in full, whichever date is earliest.
3. If the Tenant fails to make any of the payments in accordance with paragraph 2, and by the dates required, then:
 - a. The Landlord may apply under section 78 of the *Residential Tenancies Act, 2006* (the 'Act') for an order terminating the tenancy and evicting the Tenant, and for the payment of any new arrears of rent and NSF charges not already ordered under paragraph 1 of this order. The Landlord must make the application within 30 days of a breach of a condition set out in paragraph 2 of this order.
 - b. The balance owing under paragraph 1 of this order shall become payable on the day following the date of default. The monies owing shall bear interest at the post-judgment interest rate determined under subsection 207(7) of the Act.
