



**Order under Section 69
Residential Tenancies Act, 2006**

In the matter of: 702, 625 ROSELAWN AVE

Between: O'Shanter Development Company Ltd. Landlord

And

Sherwin Robin Tenant

O'Shanter Development Company Ltd. (the 'Landlord') applied for an order to terminate the tenancy and evict Sherwin Robin (the 'Tenant') because the Tenant did not pay the rent that the Tenant owes.

Prior to the videoconference hearing on April 9, 2026 the parties elected to participate in Board facilitated mediation with the assistance of a Dispute Resolution Officer (DRO).

The Landlord's Representative, Lindsay Goldberg, the Landlord Agent, Madhuri Malhotra, and the Tenant participated in the mediation. The Tenant also consulted with Tenant Duty Counsel prior to mediation.

The parties agreed to resolve all matters raised in the application and requested an order on consent. I am satisfied that the parties understood the terms and consequences of their consent.

It is agreed by the parties that:

A. Current lawful rent is \$1593.25 and it is due on the first of the month.

It is ordered on consent that:

1. The Tenant shall pay to the Landlord \$8400.05 which represents arrears of rent up to April 30, 2026 and the filing fee.

2. The Tenant shall pay to the Landlord the amount set out in paragraph 1 in accordance with the following schedule:

AMOUNT DUE	DUE DATE
\$1593.25	On or before April 17, 2026
\$250.00	On or before the 15th day of each month for 27 months from <u>May 15, 2026 to July 15, 2028</u>
\$56.80	On or before August 15, 2028

3. The Tenant shall also pay to the Landlord new rent on time and in full as it comes due and owing for the period May 1, 2026 up to and including August 1, 2028, or until the arrears are paid in full, whichever date is earliest.
4. If the Tenant fails to make any one of the payments in accordance with this order, the outstanding balance of any arrears of rent and costs to be paid by the Tenant to the Landlord pursuant to paragraph 1 of this order shall become immediately due and owing and the Landlord may, without notice to the Tenant, apply to the LTB within 30 days of the Tenant's breach pursuant to section 78 of the Act for an order terminating the tenancy and evicting the Tenant and requiring that the Tenant pay any new arrears, NSF fees and related charges that became owing after April 30, 2026.
