



**Order under Section 78(6)
Residential Tenancies Act, 2006**

And

Wallace Walter Pleasant Tenant

Toronto Seniors Housing Corporation (the 'Landlord') applied for an order to terminate the tenancy and evict Wallace Walter Pleasant (the 'Tenant') because the Tenant did not meet a condition specified in the order issued by the LTB on March 16, 2026, with respect to application LTB-L-003431-24.

This application was decided without a hearing being held.

Determinations:

1. The order provides that the Landlord can apply to the LTB under section 78 of the *Residential Tenancies Act, 2006* (the 'Act') without notice to the Tenant to terminate the tenancy and evict the Tenant if the Tenant does not meet certain condition(s) in the order. This application was filed within 30 days of the breach.
2. I find that the Tenant has not met the following condition(s) specified in the order:
 - i. **On March 9, 2026, during an inspection of the rental unit, an employee of the Landlord observed that the carbon monoxide CO2 smoke detector had been removed. A replacement detector was installed.**
 - ii. **On March 30, 2026, during a follow-up inspection, the Landlord's site staff observed that the carbon monoxide CO2 smoke detector had been removed again. Another replacement detector was installed.**

It is ordered that:

1. Order LTB-L-003431-24 is cancelled.
2. The tenancy between the Landlord and the Tenant is terminated. The Tenant must move out of the rental unit on or before April 25, 2026.

3. If the unit is not vacated on or before April 25, 2026, then starting April 26, 2026, the Landlord may file this order with the Court Enforcement Office (Sheriff) so that the eviction may be enforced.
4. Upon receipt of this order, the Court Enforcement Office (Sheriff) is directed to give vacant possession of the unit to the Landlord on or after April 26, 2026.
