



**Order under Section 69
Residential Tenancies Act, 2006**

Signet Group Inc. (the 'Landlord') applied for an order to terminate the tenancy and evict Jackie Lou Tambo and Eleodoro Lagsac (the 'Tenants') because the Tenants did not pay the rent that the Tenants owe.

The application was scheduled to be heard on April 16, 2026, by video conference, at which the parties decided to participate in Board facilitated mediation with the assistance of Dispute Resolution Officer (DRO), Maryam Cooper.

The Landlord's Representative, Matt Anderson, and the Tenants were present. Jackie Lou Tambo represented on behalf of both Tenants.

The parties mutually agreed to resolve all matters at issue in the application and requested an order on consent and I am satisfied that the parties understand the consequences of their consent.

It is ordered on consent that:

1. The Tenants shall pay to the Landlord \$7,939.04 amount for arrears of rent up to April 30, 2026, and costs.
2. The Tenants shall pay to the Landlord the amount set out in paragraph 1 in accordance with the following schedule:

Amount	Due date
\$1,350.00	On or before April 17, 2026
\$1,350.00	On or before May 15, 2026
\$1,350.00	On or before June 12, 2026
\$1,350.00	On or before July 10, 2026
\$1,350.00	On or before August 7, 2026
\$1,189.04	On or before August 21, 2026

3. The Tenants shall also pay to the Landlord new rent on time and in full as it comes due and owing for the period May 1, 2026, to August 1, 2026, or until the arrears are paid in full, whichever date is earliest.
4. If the Tenants fail to make any one of the payments in accordance with this order, the outstanding balance of any arrears of rent and costs to be paid by the Tenants to the Landlord pursuant to paragraph 1 of this order shall become immediately due and owing and the Landlord may, without notice to the Tenants, apply to the LTB within 30 days of the Tenants' breach pursuant to section 78 of the Act for an order terminating the tenancy and evicting the Tenants and requiring that the Tenants pay any new arrears, NSF fees and related charges that became owing after April 30, 2026.
