



**Order under Section 69  
Residential Tenancies Act, 2006**

SKPM Rents 22 (the 'Landlord') applied for an order to terminate the tenancy and evict Jennifer Peligrino and Shubhananda Roy (the 'Tenants') because the Tenants did not pay the rent that the Tenants owe.

This application was heard by videoconference on April 20, 2026.

The Landlord's representative, Sylwia McArthur, and the Tenant, Jennifer Peligrino, attended the hearing.

The parties before the Board consented to the following order.

**Agreed Upon Facts:**

1. As of the hearing date, the Tenants were still in possession of the rental unit.
2. The lawful rent is \$2,183.09. It is due on the 1st day of each month.
3. Based on the Monthly rent, the daily rent/compensation is \$71.77. This amount is calculated as follows:  $\$2,183.09 \times 12$ , divided by 365 days.
4. The Tenants have paid \$4,368.00 to the Landlord since the application was filed.
5. The rent arrears owing to April 30, 2026, are \$4,308.63.
6. The Landlord incurred costs of \$186.00 for filing the application and is entitled to reimbursement of those costs.

**It is ordered that:**

1. The tenancy between the Landlord and the Tenants is terminated unless the Tenants void this order.
2. **The Tenants may void this order and continue the tenancy by paying to the Landlord or to the LTB in trust:**
  - \$4,494.63 if the payment is made on or before April 30, 2026. See Schedule 1 for the calculation of the amount owing.

**OR**

- \$6,677.72 if the payment is made on or before May 31, 2026. See Schedule 1 for the calculation of the amount owing.
3. The Tenants may also make a motion at the LTB to void this order under section 74(11) of the Act, if the Tenants have paid the full amount owing as ordered plus any additional rent that became due after May 31, 2026, but before the Court Enforcement Office (Sheriff) enforces the eviction. The Tenants may only make this motion once during the tenancy.
  4. **If the Tenants do not pay the amount required to void this order the Tenants must move out of the rental unit on or before May 31, 2026.**
  5. If the Tenants do not void the order, the Tenants shall pay to the Landlord \$1,703.06. This amount includes rent arrears owing up to the date of the hearing and the cost of filing the application. The rent deposit and interest the Landlord owes on the rent deposit are deducted from the amount owing by the Tenants. See Schedule 1 for the calculation of the amount owing.
  6. The Tenants shall also pay the Landlord compensation of \$71.77 per day for the use of the unit starting April 21, 2026, until the date the Tenants move out of the unit.
  7. If the Tenants do not pay the Landlord the full amount owing on or before May 31, 2026, the Tenants will start to owe interest. This will be simple interest calculated from June 1, 2026, at 4.00% annually on the balance outstanding.
  8. If the unit is not vacated on or before May 31, 2026, then starting June 1, 2026, the Landlord may file this order with the Court Enforcement Office (Sheriff) so that the eviction may be enforced.

9. Upon receipt of this order, the Court Enforcement Office (Sheriff) is directed to give vacant possession of the unit to the Landlord on or after June 1, 2026.
