



**Order under Section 69
Residential Tenancies Act, 2006**

In the matter of: 215, 55 BRIDESBURG DR
ETOBICOKE ON M9R 2K7

Between: CAPREIT LIMITED PARTNERSHIP Landlord

and

AYANNA KING Tenant

CAPREIT LIMITED PARTNERSHIP (the 'Landlord') applied for an order to terminate the tenancy and evict AYANNA KING (the 'Tenant') because the Tenant did not pay the rent that the Tenant owes.

This application was scheduled for a videoconference hearing on April 22, 2026.

The Landlord's Representative Eshita Mongia and the Tenant engaged in private settlement discussions on the day of the hearing. Parties reached an agreement and requested an order on consent. The Tenant did not receive legal advice about this application.

I am satisfied that the parties understand the consequences of their consent, including waiving their right to a hearing on this application.

Agreed Facts:

- 1) The current rent is \$1,599.84. It is due on the 1st day of each month.
- 2) The Tenant has paid \$3,350.00 to the Landlord since the application was filed.
- 3) The rent arrears owing to April 30, 2026 are \$3,016.47.
- 4) The Landlord incurred costs of \$186.00 for filing the application and is entitled to reimbursement of those costs.

It is ordered on consent of the parties that:

1. The Tenant shall pay to the Landlord \$3,202.47. This amount includes rent arrears owing up to April 30, 2026 and the cost of filing the application.
2. The Tenant shall pay to the Landlord the amount set out in paragraph 1 in accordance with the following schedule:

June 20, 2026	\$530.00
July 20, 2026	\$530.00
August 20, 2026	\$530.00
September 20, 2026	\$530.00
October 20, 2026	\$552.47

3. The Tenant shall also pay to the Landlord new rent in full and on time for the period May 1, 2026 to October 1, 2026, or until the arrears have been paid in full, whichever date is earliest.
4. If the Tenant fails to make any one of the payments in accordance with this order, the outstanding balance of any arrears of rent and costs to be paid by the Tenant to the Landlord pursuant to paragraph 1 of this order shall become immediately due and owing and the Landlord may, without notice to the Tenant, apply to the LTB within 30 days of the Tenant's breach pursuant to section 78 of the Act for an order terminating the tenancy and evicting the Tenant and requiring that the Tenant pay any new arrears, NSF fees and related charges that became owing after April 30, 2026.
5. This order on consent is in full and final settlement of this application.
