



**Order under Section 69
Residential Tenancies Act, 2006**

File Number: LTB-L-013684-26

In the matter of: 43, 82 WILLOW AVE

Between: Westwood Holdings Inc. Landlord

And

Colleen E. Taylor Tenant

Westwood Holdings Inc. (the 'Landlord') applied for an order to terminate the tenancy and evict Colleen E. Taylor (the 'Tenant') because the Tenant did not pay the rent that the Tenant owes.

This application was heard by videoconference on April 22, 2026. The Landlord's legal representative, Bryan Rubin and the Tenant attended the hearing.

The parties resolved the matter directly and requested an order on consent.

I am satisfied that parties understand the terms and consequences of their consent, including waiving the rights to a merit hearing for this application.

Agreed Facts:

1. As of the hearing date, the Tenant was still in possession of the rental unit.
2. The lawful rent is \$1,669.03. It is due on the 1st day of each month.
3. Based on the Monthly rent, the daily rent/compensation is \$54.87. This amount is calculated as follows: \$1,669.03 x 12 months, divided by 365 days.
4. The Tenant has paid \$3,454.77 to the Landlord since the application was filed.
5. The rent arrears owing to April 30, 2026, are \$34.32.
6. The Landlord incurred costs of \$186.00 for filing the application and is entitled to reimbursement of those costs.
7. The parties agreed to amend the L1 application to reflect that the last month's rent deposit was paid by the Tenant to the Landlord on February 1, 2020, and not November 16, 2020.

8. The Landlord collected a rent deposit of \$1,500.00 from the Tenant and this deposit is still being held by the Landlord. The rent deposit can only be applied to the last rental period of the tenancy if the tenancy is terminated.
9. Interest on the rent deposit, in the amount of \$168.99 is owing to the Tenant for the period from February 1, 2020, to April 22, 2026.

It is ordered on consent that:

1. The tenancy between the Landlord and the Tenant is terminated unless the Tenant voids this order.
2. **The Tenant may void this order and continue the tenancy by paying to the Landlord or to the LTB in trust:**

- \$220.32 if the payment is made on or before April 30, 2026. See Schedule 1 for the calculation of the amount owing.

OR

- \$1,889.35 if the payment is made on or before May 31, 2026. See Schedule 1 for the calculation of the amount owing.

OR

- \$3,558.38 if the payment is made on or before June 30, 2026. See Schedule 1 for the calculation of the amount owing.

OR

- \$5,227.41 if the payment is made on or before July 31, 2026. See Schedule 1 for the calculation of the amount owing.

OR

- \$6,896.44 if the payment is made on or before August 31, 2026. See Schedule 1 for the calculation of the amount owing.

OR

- \$8,565.47 if the payment is made on or before September 30, 2026. See Schedule 1 for the calculation of the amount owing.

OR

- \$10,234.50 if the payment is made on or before October 31, 2026. See Schedule 1 for the calculation of the amount owing.

OR

- \$11,903.53 if the payment is made on or before November 30, 2026. See Schedule 1 for the calculation of the amount owing.

OR

- \$13,572.56 if the payment is made on or before December 31, 2026. See Schedule 1 for the calculation of the amount owing.
3. The Tenant may also make a motion at the LTB to void this order under section 74(11) of the Act, if the Tenant has paid the full amount owing as ordered plus any additional rent that became due after December 31, 2026, but before the Court Enforcement Office (Sheriff) enforces the eviction. The Tenant may only make this motion once during the tenancy.
 4. **If the Tenant does not pay the amount required to void this order the Tenant must move out of the rental unit on or before December 31, 2026.**
 5. As of the date of the hearing, the amount of the rent deposit and interest the Landlord owes on the rent deposit exceeds the arrears of rent, compensation and the cost of filing the application the Landlord is entitled to by \$1,910.56. See Schedule 1 for the calculation of the amount owing. However, the Landlord is authorized to deduct from the amount owing to the Tenant \$54.87 per day for compensation for the use of the unit starting April 23, 2026, until the date the Tenant moves out of the unit.
 6. The Landlord or the Tenant shall pay to the other any sum of money that is owed as a result of this order.
 7. If the unit is not vacated on or before December 31, 2026, then starting January 1, 2027, the Landlord may file this order with the Court Enforcement Office (Sheriff) so that the eviction may be enforced.
 8. Upon receipt of this order, the Court Enforcement Office (Sheriff) is directed to give vacant possession of the unit to the Landlord on or after January 1, 2027.
