



**Order under Section 69  
Residential Tenancies Act, 2006**

**In the matter of:** 102, 15 BRIDESBURG DR

**Between:** CAPREIT LIMITED PARTNERSHIP Landlord

**And**

CONROY SKYERS Tenant

CAPREIT LIMITED PARTNERSHIP (the 'Landlord') applied for an order to terminate the tenancy and evict CONROY SKYERS (the 'Tenant') because the Tenant did not pay the rent that the Tenant owes.

This application was to be heard by videoconference on April 22, 2026. The Landlord's representative, Reshma Nair, and the Tenant, Conroy Skyers, attended the hearing. The Tenant did not speak with Tenant Duty Counsel before the start of mediation.

The parties elected to participate in Board facilitated mediation with the assistance of Dispute Resolution Officer (DRO) John Russett. The parties agreed to resolve the issues in the Landlord's application and requested the LTB to issue a Consent Order confirming their agreement.

**The parties agree that:**

1. As of the hearing date, the Tenant was still in possession of the rental unit.
2. The lawful rent is \$1,645.44. It is due on the 1st day of each month.
3. Based on the Monthly rent, the daily rent/compensation is \$54.10. This amount is calculated as follows: \$1,645.44 x 12, divided by 365 days.
4. The Tenant has paid \$2,200.00 to the Landlord since the application was filed.
5. The rent arrears owing to April 30, 2026, are \$3,209.52.
6. The Landlord incurred costs of \$186.00 for filing the application and is entitled to reimbursement of those costs.
7. There is no last month's rent deposit.

**It is ordered on consent that:**

1. The tenancy between the Landlord and the Tenant is terminated unless the Tenant voids this order.
2. **The Tenant may void this order and continue the tenancy by paying to the Landlord or to the LTB in trust:**
  - \$3,395.52 if the payment is made on or before April 30, 2026. See Schedule 1 for the calculation of the amount owing.

**OR**

- \$5,040.96 if the payment is made on or before May 15, 2026. See Schedule 1 for the calculation of the amount owing.
3. The Tenant may also make a motion at the LTB to void this order under section 74(11) of the Act, if the Tenant has paid the full amount owing as ordered plus any additional rent that became due after May 15, 2026, but before the Court Enforcement Office (Sheriff) enforces the eviction. The Tenant may only make this motion once during the tenancy.
  4. **If the Tenant does not pay the amount required to void this order the Tenant must move out of the rental unit on or before May 15, 2026.**
  5. If the Tenant does not void the order, the Tenant shall pay to the Landlord \$104.64. This amount includes rent arrears owing up to the date of the hearing and the cost of filing the application. See Schedule 1 for the calculation of the amount owing.
  6. The Tenant shall also pay the Landlord compensation of \$54.10 per day for the use of the unit starting until the date the Tenant moves out of the unit.
  7. If the Tenant does not pay the Landlord the full amount owing on or before May 15, 2026, the Tenant will start to owe interest. This will be simple interest calculated from May 16, 2026, at 4.00% annually on the balance outstanding.
  8. If the unit is not vacated on or before May 15, 2026, then starting May 16, 2026, the Landlord may file this order with the Court Enforcement Office (Sheriff) so that the eviction may be enforced.
  9. Upon receipt of this order, the Court Enforcement Office (Sheriff) is directed to give vacant possession of the unit to the Landlord on or after May 16, 2026.
