



Order under Section 69 Residential Tenancies Act, 2006

File Number: LTB-L-013675-26 and LTB-L-028892-26

In the matter of: 401, 1330 WILSON AVE
NORTH YORK ON M3M1H5

Between: Sabjoy Inc Landlord

And

Jaclyn Goldthorpe Tenant

Sabjoy Inc (the 'Landlord') applied for an order to terminate the tenancy and evict Jaclyn Goldthorpe (the 'Tenant') because:

- the Tenant did not pay the rent that the Tenant owes (L1); and
- the Tenant has been persistently late in paying the Tenant's rent (L2).

Prior to the videoconference hearing on April 27, 2026 the parties elected to participate in Board facilitated mediation with the assistance of a Dispute Resolution Officer (DRO).

The Landlord's Representative, Bryan Rubin, and the Tenant participated in the mediation.

The parties agreed to resolve all matters raised in the application and requested an order on consent. I am satisfied that the parties understood the terms and consequences of their consent.

It is agreed by the parties that:

- A. As of the hearing date, the Tenant was still in possession of the rental unit.
- B. The lawful rent is \$1,491.90. It is due on the 1st day of each month.
- C. Based on the Monthly rent, the daily rent/compensation is \$49.05. This amount is calculated as follows: $\$1,491.90 \times 12$, divided by 365 days.
- D. The Tenant has paid \$2,983.80 to the Landlord since the application was filed.
- E. The rent arrears owing to April 30, 2026 are \$2,982.56.
- F. The Landlord incurred costs of \$186.00 for filing the application and is entitled to reimbursement of those costs.

- G. The Landlord collected a rent deposit of \$1,390.82 from the Tenant and this deposit is still being held by the Landlord. The rent deposit can only be applied to the last rental period of the tenancy if the tenancy is terminated.

It is ordered on consent that:

L1 Application (LTB-L-013675-26)

1. The tenancy between the Landlord and the Tenant is terminated unless the Tenant voids this order.
2. **The Tenant may void this order and continue the tenancy by paying to the Landlord or to the LTB in trust:**
 - \$3,168.56 if the payment is made on or before April 30, 2026. See Schedule 1 for the calculation of the amount owing.

OR

- \$4,660.46 if the payment is made on or before May 15, 2026. See Schedule 1 for the calculation of the amount owing.
3. The Tenant may also make a motion at the LTB to void this order under section 74(11) of the Act, if the Tenant has paid the full amount owing as ordered plus any additional rent that became due after May 15, 2026 but before the Court Enforcement Office (Sheriff) enforces the eviction. The Tenant may only make this motion once during the tenancy.
 4. **If the Tenant does not pay the amount required to void this order the Tenant must move out of the rental unit on or before May 15, 2026.**
 5. If the Tenant does not void the order, the Tenant shall pay to the Landlord \$1,610.19. This amount includes rent arrears owing up to the date of the hearing and the cost of filing the application. The rent deposit and interest the Landlord owes on the rent deposit are deducted from the amount owing by the Tenant. See Schedule 1 for the calculation of the amount owing.
 6. The Tenant shall also pay the Landlord compensation of \$49.05 per day for the use of the unit starting April 28, 2026 until the date the Tenant moves out of the unit.
 7. If the Tenant does not pay the Landlord the full amount owing on or before May 15, 2026, the Tenant will start to owe interest. This will be simple interest calculated from May 16, 2026 at 4.00% annually on the balance outstanding.
 8. If the unit is not vacated on or before May 15, 2026, then starting May 16, 2026, the Landlord may file this order with the Court Enforcement Office (Sheriff) so that the eviction may be enforced.
 9. Upon receipt of this order, the Court Enforcement Office (Sheriff) is directed to give vacant possession of the unit to the Landlord on or after May 16, 2026.
 10. LTB-L-031675-26 shall be amended to remove the L2 application.

L2 Application (LTB-L-028892-26)

11. If the Tenant voids the L1 portion of the order by making the required payment in accordance with paragraph 2 above, the tenancy shall continue on the condition that for a period of **twelve (12) months** from **June 1, 2026 until and including May 1, 2027**, the Tenant shall pay rent in full and on time by the first (1st) day of the month.
12. If the Tenant fails to comply with the conditions set out in paragraph 11 of this order, the Landlord may apply under section 78 of the *Residential Tenancies Act, 2006* (the 'Act') for an order terminating the tenancy and evicting the Tenant. The Landlord must make the application within 30 days of a breach of a condition. This application is made to the LTB without notice to the Tenant.
13. The Landlord is waiving the \$186.00 cost of filing application LTB-L-028892-26.

Other Terms

14. This order resolves LTB-L-013675-26 and LTB-L-028892-26.
