



**Order under Section 78(11)
Residential Tenancies Act, 2006**

Tadian Wilson Tenant

MetCap Living Management Inc. (the 'Landlord') applied for an order to terminate the tenancy and evict Tadian Wilson (the 'Tenant') and for an order to have the Tenant pay the rent they owe because the Tenant did not meet a condition specified in the order issued by the LTB on February 10, 2026 with respect to application LTB-L-105634-25.

The Landlord's application was resolved by order LTB-L-022610-26, issued on March 17, 2026. This order was issued without a hearing being held.

The Tenant filed a motion to set aside order LTB-L-022610-26.

This motion was heard by videoconference on April 30, 2026. The Landlord's representative Stella Idahosa, and the Tenant, attended the hearing.

The Landlord consents to the Tenant's motion to set aside. The parties agree the Tenant owes the Landlord \$3,850.64 in arrears and costs to the end of April 2026.

At the hearing the parties consented to the following order.

On consent it is ordered that:

1. The motion to set aside Order LTB-L-022610-26, issued on March 17, 2026, is granted.
2. Order LTB-L-022610-26, issued on March 17, 2026, is set aside and cannot be enforced.
3. Order LTB-L-105634-25 is cancelled and replaced with the following:
4. The Tenant shall pay to the Landlord \$3,850.64 as follows:

- The Tenant shall pay to the Landlord \$641.77 on or before the 25th day of each consecutive month commencing May 2026 and continuing through September 2026.
 - The Tenant shall pay to the Landlord \$641.79 on or before October 25, 2026.
5. The Tenant shall also pay to the Landlord the lawful rent in full and on time for each consecutive month commencing May 2026 and continuing through October 2026, or until the arrears and costs are paid in full.
 6. In the event the Tenant fails to make the above said payments in full and on time, the entire balance of the amount set out in this Order will become due and payable forthwith under this Order. The Landlord shall be entitled to apply to the Board, no later than 30 days after a breach of this Order, without notice to the Tenant, for an Order terminating the tenancy and evicting the Tenant and for any arrears that become due after the date of this order, pursuant to Section 78 of the Residential Tenancies Act, 2006.
