



**Order under Section 69
Residential Tenancies Act, 2006**

VEGSO ATTILA Tenant

FAIRWAY RESIDENTIAL (1577 LAWRENCE AVENUE WEST) LP (the 'Landlord') applied for an order to terminate the tenancy and evict VEGSO ATTILA (the 'Tenant') because the Tenant did not pay the rent that the Tenant owes.

This application was heard by videoconference on April 30, 2026. The Landlord's Representative, Sean Beard, and the Tenant, assisted by Vanessa Horvath, who provided translation to the Tenant, attended the hearing.

Determinations:

1. The Landlord served the Tenant with a valid Notice to End Tenancy Early for Non-payment of Rent (N4 Notice). The Tenant did not void the notice by paying the amount of rent arrears owing by the termination date in the N4 Notice or before the date the application was filed.
2. As of the hearing date, the Tenant was still in possession of the rental unit.
3. The lawful rent is \$2,179.00. It is due on the 1st day of each month.
4. Based on the Monthly rent, the daily rent/compensation is \$71.64. This amount is calculated as follows: \$2,179.00 x 12, divided by 365 days.
5. The Tenant has not made any payments since the application was filed.
6. The rent arrears owing to April 30, 2026, are \$13,074.00.
7. The Landlord incurred costs of \$186.00 for filing the application and is entitled to reimbursement of those costs.

8. The Landlord collected a rent deposit of \$1,773.70 from the Tenant and this deposit is still being held by the Landlord. The rent deposit can only be applied to the last rental period of the tenancy if the tenancy is terminated.
9. Interest on the rent deposit, in the amount of \$12.25 is owing to the Tenant for the period from January 1, 2026, to April 30, 2026.
10. I have considered all of the disclosed circumstances in accordance with subsection 83(2) of the *Residential Tenancies Act, 2006* (the 'Act'), and find that it would not be unfair to postpone the eviction until May 31, 2026, pursuant to subsection 83(1)(b) of the Act. The Landlord seeks a standard order, that is, an order which can be enforced 11 days after its issuance.
11. The Tenant states that he lost his job because his partner is suffering with mental health problems. He has been looking for a job, but it has been more challenging to find one because it must be an afternoon shift so he can pick up his children from school. The couple have four children aging from 3 to 11 years old. The family is currently living on funds from Ontario Works. The Tenant wishes to be given until June 30, 2026, so that the children can finish their school year.
12. I am of the view that a short delay in termination to May 31, 2026, is warranted in the circumstances given the Tenant has four young children. However, I am not persuaded that a termination date to the end of June is appropriate. The Tenant has not made any payments towards the rent for six consecutive months. The Tenant's last months' rent deposit can be applied to the month of May 2026, which will reduce further prejudice to the Landlord.

It is ordered that:

1. The tenancy between the Landlord and the Tenant is terminated unless the Tenant voids this order.
2. **The Tenant may void this order and continue the tenancy by paying to the Landlord or to the LTB in trust:**
 - \$15,439.00 if the payment is made on or before May 31, 2026. See Schedule 1 for the calculation of the amount owing.
3. The Tenant may also make a motion at the LTB to void this order under section 74(11) of the Act, if the Tenant has paid the full amount owing as ordered plus any additional rent that became due after May 31, 2026 but before the Court Enforcement Office (Sheriff) enforces the eviction. The Tenant may only make this motion once during the tenancy.
4. **If the Tenant does not pay the amount required to void this order the Tenant must move out of the rental unit on or before May 31, 2026.**
5. If the Tenant does not void the order, the Tenant shall pay to the Landlord \$11,474.05. This amount includes rent arrears owing up to the date of the hearing and the cost of filing the application. The rent deposit and interest the Landlord owes on the rent deposit are

deducted from the amount owing by the Tenant. See Schedule 1 for the calculation of the amount owing.

6. The Tenant shall also pay the Landlord compensation of \$71.64 per day for the use of the unit starting May 1, 2026 until the date the Tenant moves out of the unit.
7. If the Tenant does not pay the Landlord the full amount owing on or before May 31, 2026, the Tenant will start to owe interest. This will be simple interest calculated from June 1, 2026 at 4.00% annually on the balance outstanding.
8. If the unit is not vacated on or before May 31, 2026, then starting June 1, 2026, the Landlord may file this order with the Court Enforcement Office (Sheriff) so that the eviction may be enforced.
9. Upon receipt of this order, the Court Enforcement Office (Sheriff) is directed to give vacant possession of the unit to the Landlord on or after June 1, 2026.

**Ongoing daily compensation continues to accumulate until the total amount owing (excluding costs) is \$50,000.00.
