



**Order under Section 69
Residential Tenancies Act, 2006**

bcIMC Realty Corporation c/o QuadReal Residential Properties G.P. Inc. (the 'Landlord') applied for an order to terminate the tenancy and evict Ghazal Afzali (the 'Tenant') because they did not pay the rent that is owed.

This application was heard by videoconference on April 30, 2026.

The Landlord's legal representative Faith McGregor and the Tenant attended the hearing.

At the hearing, the parties consented to the following order. I am satisfied that the understood the consequences of consenting to the issuance of this order and that the parties present gave full and informed consent.

Determinations:

1. The parties requested that the Landlord's application be amended to remove Mohsen Nazari as a respondent. I granted this request at the hearing and Mr. Nazari is removed as a responding party.
2. The lawful rent is \$3,111.11. It is due on the 1st day of each month.
3. The rent arrears owing to April 30, 2026 are \$18,476.41.
4. The Landlord incurred costs of \$186.00 for filing the application and is entitled to reimbursement of those costs.
5. The Landlord collected a rent deposit of \$3,111.11 from the Tenant and this deposit is still being held by the Landlord. The rent deposit can only be applied to the last rental period of the tenancy if the tenancy is terminated.
6. Interest on the rent deposit, in the amount of \$21.48 is owing to the Tenant for the period from January 1, 2026 to April 30, 2026.

It is ordered on consent that:

1. Mohsen Nazari is removed as a responding party to the Landlord's application.
2. The tenancy between the Landlord and the Tenant is terminated unless the Tenant voids this order.
3. **The Tenant may void this order and continue the tenancy by paying to the Landlord or to the LTB in trust:**
 - \$21,773.52 if the payment is made on or before May 15, 2026. See Schedule 1 for the calculation of the amount owing.
4. The Tenant may also make a motion at the LTB to void this order under section 74(11) of the Act, if the Tenant has paid the full amount owing as ordered plus any additional rent that became due after May 15, 2026 but before the Court Enforcement Office (Sheriff) enforces the eviction. The Tenant may only make this motion once during the tenancy.
5. **If the Tenant does not pay the amount required to void this order the Tenant must move out of the rental unit on or before May 15, 2026.**
6. If the Tenant does not void the order, the Tenant shall pay to the Landlord \$15,529.82. This amount includes rent arrears owing up to the date of the hearing and the cost of filing the application. The rent deposit and interest the Landlord owes on the rent deposit are deducted from the amount owing by the Tenant. See Schedule 1 for the calculation of the amount owing.
7. The Tenant shall also pay the Landlord compensation of \$102.28 per day for the use of the unit starting May 1, 2026 until the date the Tenant moves out of the unit.
8. If the Tenant does not pay the Landlord the full amount owing on or before May 15, 2026, the Tenant will start to owe interest. This will be simple interest calculated from May 16, 2026 at 4.00% annually on the balance outstanding.
9. If the unit is not vacated on or before May 15, 2026, then starting May 16, 2026, the Landlord may file this order with the Court Enforcement Office (Sheriff) so that the eviction may be enforced.
10. Upon receipt of this order, the Court Enforcement Office (Sheriff) is directed to give vacant possession of the unit to the Landlord on or after May 16, 2026.
