



**Order under Section 69
Residential Tenancies Act, 2006**

EAST BRIAR TOWERS LIMITED (the 'Landlord') applied for an order to terminate the tenancy and evict UGUR TASCI and MULLA SAHIN (the 'Tenants') because the Tenants did not pay the rent that the Tenants owe.

This application was heard by videoconference on May 4, 2026. The Landlord's legal representative, Emily Barbaty and the Tenant, Ugur Tasci attended the hearing.

The parties resolved the matter directly and requested an order on consent.

I am satisfied that parties understand the terms and consequences of their consent, including waiving the rights to a merit hearing for this application.

Agreed Facts:

1. The parties agreed to amend the application to reflect the correct spelling of the Tenant's name as Ugur Tasci.
2. As of the hearing date, the Tenants were still in possession of the rental unit.
3. The lawful rent is \$2,644.39. It is due on the 1st day of each month.
4. Based on the Monthly rent, the daily rent/compensation is \$86.94. This amount is calculated as follows: \$2,644.39 x 12 months, divided by 365 days.
5. The Tenants have not made any payments since the application was filed.
6. The rent arrears owing to May 31, 2026, are \$13,197.59.

7. The Landlord incurred costs of \$186.00 for filing the application and is entitled to reimbursement of those costs.
8. The Landlord collected a rent deposit of \$2,644.39 from the Tenants and this deposit is still being held by the Landlord. The rent deposit can only be applied to the last rental period of the tenancy if the tenancy is terminated.
9. Interest on the rent deposit, in the amount of \$18.87 is owing to the Tenants for the period from January 1, 2026, to May 4, 2026.

It is ordered on consent that:

1. The tenancy between the Landlord and the Tenants is terminated unless the Tenants void this order.
2. **The Tenants may void this order and continue the tenancy by paying to the Landlord or to the LTB in trust:**
 - \$13,383.59 if the payment is made on or before May 19, 2026. See Schedule 1 for the calculation of the amount owing.
3. The Tenants may also make a motion at the LTB to void this order under section 74(11) of the Act, if the Tenants have paid the full amount owing as ordered plus any additional rent that became due after May 19, 2026, but before the Court Enforcement Office (Sheriff) enforces the eviction. The Tenants may only make this motion once during the tenancy.
4. **If the Tenants do not pay the amount required to void this order the Tenants must move out of the rental unit on or before May 19, 2026.**
5. If the Tenants do not void the order, the Tenants shall pay to the Landlord \$8,423.70. This amount includes rent arrears owing up to the date of the hearing and the cost of filing the application. The rent deposit and interest the Landlord owes on the rent deposit are deducted from the amount owing by the Tenants. See Schedule 1 for the calculation of the amount owing.
6. The Tenants shall also pay the Landlord compensation of \$86.94 per day for the use of the unit starting May 5, 2026, until the date the Tenants move out of the unit.
7. If the Tenants do not pay the Landlord the full amount owing on or before May 19, 2026, the Tenants will start to owe interest. This will be simple interest calculated from May 20, 2026, at 4.00% annually on the balance outstanding.
8. If the unit is not vacated on or before May 19, 2026, then starting May 20, 2026, the Landlord may file this order with the Court Enforcement Office (Sheriff) so that the eviction may be enforced.

9. Upon receipt of this order, the Court Enforcement Office (Sheriff) is directed to give vacant possession of the unit to the Landlord on or after May 20, 2026.
