



**Order under Section 69
Residential Tenancies Act, 2006**

File Number: LTB-L-019864-26

In the matter of: 1109, 35 WALMER RD

Between: SKPM RENTS 14 Landlord

And

DEXTER HOLDEN Tenant

SKPM RENTS 14 (the 'Landlord') applied for an order to terminate the tenancy and evict DEXTER HOLDEN (the 'Tenant') because the Tenant did not pay the rent that the Tenant owes.

This application was heard by videoconference on May 19, 2026.

The Landlord's representative, Sara Ginman, and the Tenant attended the hearing.

Determinations:

1. The Landlord served the Tenant with a valid Notice to End Tenancy Early for Non-payment of Rent (N4 Notice). The Tenant did not void the notice by paying the amount of rent arrears owing by the termination date in the N4 Notice or before the date the application was filed.
2. As of the hearing date, the Tenant was still in possession of the rental unit.
3. The lawful rent is \$2,330.79. It is due on the 1st day of each month.
4. Based on the Monthly rent, the daily rent/compensation is \$76.63. This amount is calculated as follows: \$2,330.79 x 12, divided by 365 days.
5. The Tenant has not made any payments since the application was filed.
6. The rent arrears owing to May 31, 2026 are \$9,323.16.
7. The Landlord incurred costs of \$186.00 for filing the application and is entitled to reimbursement of those costs.
8. The Landlord collected a rent deposit of \$2,330.79 from the Tenant and this deposit is still being held by the Landlord. The rent deposit can only be applied to the last rental period of the tenancy if the tenancy is terminated.

9. Interest on the rent deposit, in the amount of \$18.64 is owing to the Tenant for the period from January 1, 2026 to May 19, 2026.
10. The Tenant requested the Board grant him relief from eviction and proposed a payment plan. The Landlord opposed the payment plan as the Tenant had not made any payments since the filing of this application. I find in favour of the Landlord as the Tenant testified that he earns \$3,560.00 a month, but did not provide any documentary evidence to substantiate their position. On a balance of probabilities, I am not convinced that continuing the tenancy is viable as the Tenant has made zero payments since the filing of the application.
11. The Tenant requested if the Board were to grant the Landlord's application, the not delay eviction. I have considered all of the disclosed circumstances in accordance with subsection 83(2) of the *Residential Tenancies Act, 2006* (the 'Act'), and find that it would not be unfair to postpone the eviction until June 30, 2026 pursuant to subsection 83(1)(b) of the Act.
12. I have delayed the eviction to June 30, 2026 as the Landlord holds a last month rent deposit, that will be applied to the last month of tenancy, reducing serious prejudice on the Landlord, but also providing the Tenant with more time to find alternative housing arrangements.

It is ordered that:

1. The tenancy between the Landlord and the Tenant is terminated unless the Tenant voids this order.
 2. **The Tenant may void this order and continue the tenancy by paying to the Landlord or to the LTB in trust:**
 - \$9,509.16 if the payment is made on or before May 31, 2026. See Schedule 1 for the calculation of the amount owing.
- OR**
- \$11,839.95 if the payment is made on or before June 30, 2026. See Schedule 1 for the calculation of the amount owing.
 3. The Tenant may also make a motion at the LTB to void this order under section 74(11) of the Act, if the Tenant has paid the full amount owing as ordered plus any additional rent that became due after June 30, 2026 but before the Court Enforcement Office (Sheriff) enforces the eviction. The Tenant may only make this motion once during the tenancy.
 4. **If the Tenant does not pay the amount required to void this order the Tenant must move out of the rental unit on or before June 30, 2026.**
 5. If the Tenant does not void the order, the Tenant shall pay to the Landlord \$6,284.91. This amount includes rent arrears owing up to the date of the hearing and the cost of filing the application. The rent deposit and interest the Landlord owes on the rent deposit are

deducted from the amount owing by the Tenant. See Schedule 1 for the calculation of the amount owing.

6. The Tenant shall also pay the Landlord compensation of \$76.63 per day for the use of the unit starting May 20, 2026 until the date the Tenant moves out of the unit.
7. If the Tenant does not pay the Landlord the full amount owing on or before June 30, 2026, the Tenant will start to owe interest. This will be simple interest calculated from July 1, 2026 at 4.00% annually on the balance outstanding.
8. If the unit is not vacated on or before June 30, 2026, then starting July 1, 2026, the Landlord may file this order with the Court Enforcement Office (Sheriff) so that the eviction may be enforced.
9. Upon receipt of this order, the Court Enforcement Office (Sheriff) is directed to give vacant possession of the unit to the Landlord on or after July 1, 2026.
